201145. GCRA 10 Year Reinvestment Roadmap Follow Up (B)

Explanation: At the April 7 Joint GCRA/City Commission meeting, GCRA Advisory
Board Members requested that staff return with updated budget
information to include revenue sources in the spreadsheet GCRA was
using as a project management tool. Follow-up to that item was included
on the May 18 GCRA Advisory Board agenda (#201193), however, due to
time constraints the item was not presented. That presentation is included
as backup to this informational item that further refines the GCRA 10
Year Plan management tool. This spreadsheet is continually updated to

201105. 8th & Waldo Project Update (B)

Explanation: The 36-acre City-owned 8th & Waldo project area was identified in 2018 as a unique opportunity to catalyze economic development in east Gainesville. The City of Gainesville 2020-2025-2035 Strategic Plan identified 8th & Waldo Land Acquisition as a High Priority. The 2019 Gainesville Community Reinvestment Area (GCRA) 10-year Reinvestment Plan identified the 8th & Waldo area as an Economic Development Initiative Core.

In January 2021, the GCRA Advisory Board advised CAPER to pursue community engagement, and approved the allocation of \$4,000 for this task.

A Phase I Environmental Assessment (ESA) was conducted by Water & Air research, Inc. in April 2021. This assessment has revealed evidence of recognized environmental conditions in connection with the property. A Phase II ESA is recommended to further investigate the Recognized Environmental Conditions (RECs) documented during the Phase I ESA. The Phase II ESA will focus on the areas of concern west of NE 14th Street. No further environmental investigation is needed in the geographic area within the GCRA portion of the site.

Today's presentation will review the complete and undergoing due diligence, and the anticipated project process and timeline.

201192. Downtown Strategic Plan Project Update (B)

Explanation: The Strategic Plan for Downtown is a Top Priority project for the City

Commission City Strategic Plan: 2020-2025-2035. A contract with a consulting group, led by MKSK and EDA, co-funded by the GCRA and UF, was executed in 11/2020. The project was assigned to the Office of Capital Asset Planning & Economic Resilience (CAPER). Since project initiation, project team held introductory meetings with internal stakeholders, including City staff, GCRA Advisory Board, one-one-one meetings with City Commissioners, Alachua County staff, UF staff, as well as site visits, and information gathering.

On April 8, the GPC approved an Engagement Brief for the project that was developed by MKSK in close collaboration with the Department of Communications and Engagement, Office of Equity and Inclusion, GCRA, UF, and CAPER staff.

As part of the engagement strategy, a Neighbor Advisory Group (NAG) will be established. The NAG, including up to 15 members, will be a representative voice of the Gainesville community that will directly guide the process. Members will provide critical feedback, establish the plan's guiding principles, and guide the direction for the planning process. Members will serve as ambassadors of the project, actively communicating and advocating for the plan's shared vision. The group will meet 4-6 times throughout the process. The NAG will include one (1) representative from the following organizations: GCRA Advisory Board, Alachua County, UF, Innovation Hub, and the Chamber of Commerce. The 5 abovementioned members will invite up to 10 members that represent downtown property and business owners and Gainesville neighbors to become members of the NAG.

In the presentation, we will introduce the project overall and engagement approach, timeline and next steps.

Follow Up

Explanation: At the March 16 GCRA Advisory Board meeting, the Cultural Arts Coalition requested funding for the 2021 Fifth Avenue Arts Festival in the amount of \$2,000 from the GCRA's Community Partnerships fund (Legistar #200936). The board unanimously approved the funding and requested that the Cultural Arts Coalition return to the board after the event to report on how the funds were spent and how the event went. The Fifth Avenue Arts Festival took place from April 24 through May 3, 2021, and at today's meeting the Cultural Arts Coalition will return to the board with the requested information.

200904. GCRA and CWC Partnership Initiative (B)

Explanation: The proposed Reinvestment Area Home Energy and Water Efficiency Initiative is a partnership between the Community Weatherization Coalition (CWC) of Alachua County and Gainesville Community Reinvestment Area (GCRA). The vision of this Initiative is to strengthen neighborhoods by maintaining the culture and population of the district neighborhoods through long term residency. The mission being to directly benefit community members by lowering their monthly utility bill and thus increasing the number of energy and water efficient homes in the District. Residents with inefficient appliances, poorly functioning air conditioning, and water leaks may spend hundreds to thousands of dollars in additional annual costs. In addition, areas of poor quality housing and a large numbers of inefficient homes can destabilize communities by leading to a high turnover rate for permanent residents.

The CWC currently provides free services to homeowners through the Home Energy Tune-up (Tier 1) and Upgrade (Tier 2) Programs. The Tune-up (Tier 1) Program offers a free kit that contains water and energy saving supplies, as well as education on conservation behaviors. These supplies include energy-efficient light bulbs, water-saving showerheads, and toilet tank displacement bags. The Upgrade (Tier 2) Program offers more permanent energy upgrade services such as installation of attic and underfloor insulation, water heater replacement, and window pane replacement. Both programs are designed to lower the residential energy cost burden-or the percent of a resident's annual household income that goes toward energy costs.

Through the partnership, the GCRA would provide funding for each low income participant or lessor (within the district) the CWC provides services to. The objective is to increase the number of energy and water efficient homes and expand the program to rental property owners (lessors). By helping residents save money on energy costs, the initiative supports the GCRA 10 Year Reinvestment Plan goals.

The Reinvestment Plan supports the Initiative's vision through the Plan's

"Community Enhancement and Housing Objective." The purpose of this objective is to directly benefit community members by maintaining the culture and population of neighborhoods. The Gainesville City Commission's Strategic Plan also outlines steps to create a "Great Place to Live & Experience" (Goal 3) by increasing affordable housing opportunities for both ownership and rental units.

Fiscal Note: The total estimated cost for one year to implement the initiative is \$70,132.00. Funding has been budgeted for and will be utilized from the GCRA Fund W022. As this is a pilot program GCRA and CWC have committed to reviewing the efficacy of the program and any suggested changes will be brought back prior to the first year anniversary of the program.

200401. Heartwood Update (B)

Explanation: On May 6, 2021, the City Commission approved the Purchase and Sale Agreements (PSA) and Construction Contracts for Heartwood. This was the final step needed to kick off the marketing and start the timeline for sales and construction.

The Heartwood website, heartwoodgnv.com http://www.Heartwoodgnv.com, went live on Friday, May 16, 2021. To date, the website has had over 2,100 visitors since launching, with the most frequently visited pages being "Home Models" and "How to Buy." The GCRA's communications reached over 1,400 interested neighbors via direct email and was also posted to the GCRA and Heartwood websites, GCRA Facebook and Instagram, and a formal press release was issued. Keller Williams - Team Dynamo marketing communications reached over 11,000 interested neighbors via direct mail, and was posted on the Multiple Listing Service (MLS) and Team Dynamo's social media outlets. The following news outlets have also recently published articles about the Heartwood neighborhood; WUFT, the Gainesville Sun, and the Main Street Daily News.

On Wednesday, June 2, 2021, Staff held two virtual Homebuyer Informational Sessions to provide the public an opportunity to meet with the Heartwood Team, hear about the two purchasing paths, ask critical questions, and receive a virtual tour of the model home. Between the two sessions, there was a total of 57 attendees and over 60 questions asked. The event was recorded and is accessible via the Heartwood website.

The next two Heartwood events will be an on-site "Neighborhood Drive-Through and Open House" on Wednesday, June 16, 2021 from 3-6 p.m. and "Heartwood Sales Day" on June 30, 2021. At today's meeting, staff will provide an update and more information on the upcoming events.
