## **210129. Solid Waste Ordinance Updates (B)**

Explanation: The Zero Waste Subcommittee has been meeting to discuss various policies related to the reduction, reuse, and recycling of solid waste.

Based on this input, community builders have drafted changes to the City's Code of Ordinances to address the commercial, multifamily, special events, and food waste categories.

On July 20, 2021, the Zero Waste Subcommittee heard a presentation from community builders on proposed changes to the City's ordinance and provided direction on additional changes. The Committee also directed community builders to coordinate a "Town Hall" meeting where neighbors and stakeholders can provide input to possible changes to the Solid Waste Ordinance.

On August 31, 2021, the Zero Waste Subcommittee held a Town Hall to discuss proposed ordinance changes and get input from the community. The Subcommittee requested that Community Builders from the Solid Waste Division and the City Attorney's Office return with an update in a month.

# **200449.** Discussion of Construction and Demolition Waste in Gainesville (NB)

Explanation: On October 27, 2020, Community Builders presented information on Construction and Demolition Debris in the community and received feedback from the Subcommittee.

On December 8, 2020, Community Builders presented possible concepts on how a Construction and Demolition Ordinance might work.
