## 211166. Regional Transit System (RTS) Proposed Fall 2022 Transit Service Changes (B)

### **200737.** Street Lighting and Vegetation Management (B)

AGENDA UPDATE - ADDED ITEM

Explanation: At the February 11th, 2021 General Policy Committee Meeting, the City Commission received a presentation on street lighting and the impact trees have on lighting levels (Legislative File #200737).

The City Commission specifically made the following motion of staff:

- 1. Staff to put together a policy task force internally to bring back right-of-way lighting recommendations that focus on lighting classifications for high pedestrian density zones and a spectrum going all the way to the dark sky zones, including a cost benefit analysis that includes tree maintenance.
- 2. Make a referral to both the police advisory council and a tree advisory board of those boards, have them discuss it independently and then have a joint meeting working with Staff. And bring us back a recommendation for that sort of balance that we're trying to strike between safety and preserving our heritage trees and our tree canopy.
- 3. Get a budget estimate on both a vegetation maintenance increment and an increased lighting in dark areas increment as well as referring the issue of lighting safety to the police advisory council and the tree advisory board.
- 4. Staff to bring back information or data stats for our high crime areas

that have been impacted by lighting or no lighting or less lighting and what that analysis looked like and what a cost would be for us to prioritize going into those neighborhoods and addressing those lighting issues.

An internal team was established to revue these issues and make recommendations back to the City Commission. That committee reviewed the issues, conducted a field visit on a Friday to see firsthand the conditions and developed a report to document their findings.

Fiscal Note: Currently, trees are trimmed around streetlights every 3 years. To trim around the streetlights every year would require an additional \$755,000 annually in funds to contract this service out.

Strategic Connection:

This project is related to 2 goals: Goal 3: "A Great Place to Live & Experience" – objective 2. "Develop a vibrant, alive Downtown with expanded residential, entertainment and commercial opportunities." It is also connected to Goal 5: "Best In Class" Neighbor Services". It aids in objective 5. Have a high level of neighbor satisfaction with city services and services response.

<u>RECOMMENDATION</u>
The City Commission: 1) hear a presentation from staff; and, 2) take action, as appropriate.
