AGENDA UPDATE - NEW BACK-UP

Explanation: Subcommittees are standing committees organized around a specific policy field, typically composed of 2-3 commission members per subcommittee along with any staff members relevant to the policies and programs being discussed. These subcommittees discuss specific policies and create recommendations on how to move the issue forward. With the exception of two standing subcommittees (the Audit and Finance Committees), the City of Gainesville primarily utilizes the General Policy Committee (GPC) model to advance policy discussions rather than utilizing the subcommittee model. The General Policy Committee model has been in place since 2016, with subcommittees preceding it. The attached report and presentation discuss common committee and advisory board structures in cities in Florida and around the country, and advantages and disadvantages to the extensive usage of subcommittees.

DP-6 <u>211212.</u> Lien Reduction Process (B)

Explanation: Currently in the City of Gainesville, when a property has a lien assessed against it due to code compliance violations, the property owner can request a reduction in the lien if the property comes into compliance with city code. After the request is made, a meeting is held between the property owner/representative and the Code Enforcement Manager and the Director of the Department of Sustainable Development to discuss the amount of the lien and attempt to reach a negotiated agreement on the amount to be paid by the city. After this meeting, a hearing is held by the Special Magistrate, and the Special Magistrate makes a recommendation as to whether to keep the lien as is, reduce the lien, or rescind the lien entirely. However, the Magistrate's decision is not final, and the City Commission must approve the recommendation at a City Commission meeting for that decision to be made final. While Florida State Statutes indicate that the "local governing body" may execute a satisfaction or release of a lien, the statutes specifically authorize code enforcement boards to reduce fines, and several cities across the State of Florida have

adopted local ordinances which allow for their Special Magistrate to be the final decision maker on the reduction of liens. It is the interpretation of the Gainesville City Attorney's Office that Florida State Statutes indicate that while the Special Magistrate may be authorized to be the final decision maker on lien reductions, the City Commission must authorize the release of code enforcement liens, either by an agenda item (which could be on a Consent Agenda), or by ordinance specifically authorizing the City Manager to execute releases of liens where the fines have been reduced by final action of the Special Magistrate.

DP-7 <u>211192.</u> Discussion: Municipal General Obligation Housing Bonds (B)

AGENDA UPDATE - REVISED BACK-UP

Explanation: General obligation bonds are debt securities issued by state or local governments backed by property taxes to raise money for affordable housing development and related programming. These bonds should be used for the purposes of purchasing, building of new housing, preservation of affordable housing, purchasing of land and housing vouchers. This bond would need to be placed on the ballot for a voter approved referendum. The November 2022 general election would be next best election to place the referendum.

Key Characteristics of General Obligation Bonds:

-Include certain legal advertising requirements.

-General obligation bonds are the highest credit quality given they are secured by a pledge of the full faith, credit and taxing power of the City without limitation (AA for the City of Gainesville).

-Often used to fund high priority projects that have broad community support.

-A separate ad valorem millage levy is added to the annual tax roll to pay the debt service cost (does not count toward the 10 mill cap).

-The size of the bond issue and the term of the repayment are outlined in the referendum. Bonds are often issued in multiple series over a period of time for larger referendums. This allows for the millage levy to increase over time as the bonds are issued.

RECOMMENDATION

The City Commission direct staff to come back in thirty (30) days with a proposed framework for a

\$30 - \$50 million general obligation bond, including the household cost of the tax and the number of units that could be built or preserved.
