10	which adopted fee increases for the Controlled Vehicular Parking Area Decals/Permits section of			
11	Appendix A; and			
12	WHEREAS, prior to the adoption of Ordinance No. 210189, the City Commission held a			
13	meeting on July 12, 2021 and approved proposed fee increases to the Controlled Vehicular Parking			
14	Area Decals/Permits section of Appendix A; and			
15	WHEREAS, the proposed fee increases were used in developing the budget for Fiscal			
16	Year 2022; and			
17	WHEREAS, after Ordinance No. 210189 was passed, staff discovered an error in the fees			
18	for commercial permits and service permits; and			
19	WHEREAS, it is necessary to revise Appendix A to include the correct and intended fees			
20	for commercial permits and service permits that the City Commission approved on July 12, 2021			
21	and that were used in developing the Fiscal Year 2022 budget; and			
22	WHEREAS, at least ten (10) days' notice has been given once by publication in a			
23	newspaper of general circulation notifying the public of this proposed ordinance and of the public			
24	hearings in the City Hall Auditorium located on the first floor of City Hall in the City of			
25	Gainesville; and			
26	WHEREAS, public hearings were held pursuant to the published notice described above,			
27	at which all interested parties had an opportunity to be, and were, in fact, heard.

58	finding shall not affect the other provisions or applications of the ordinance which can be given				
59	effect without the invalid or unconstitutional provisions or application, and to this end the				
60	provisions of this ordinance are declared severable.				
61	Section 4. All ordinances, or parts of ordinances, in conflict herewith are to the extent of				
62	such conflict hereby repealed on the effective date of this ordinance.				
63	Section 5. This ordinance shall take effect immediately upon adoption.
