

The nutrients will be applied both via granular and foliar applications. A large percentage of the delivered nutrients will be applied via foliar fertilizer applications to fairways and tees. Granular fertilizers will be used to apply slow release organic-based fertilizers, polymer coated Urea technologies and herbicides, such as Ronstar. Additional fertility will be applied to surfaces to promote bermudagrass establishment and recovery from fall overseeding while reducing weed pressure (sedge, kyllinga and spurge). Spot treatment applications of additional fertilizer will be applied to weak/thin areas as needed. Additional soil nutrient tests will be performed to further adjust this fertility program.

Cultural Programs - Fairways and tees will be core aerified twice per year and solid tine aerified in areas of high traffic. Tees will be topdressed with an appropriate sand in conjunction with core aerification events.

Overseeding – Tees /Fairways will be overseeded in fall months.


Pest Control Program(s) - A variety of weeds and pests are expected on hybrid bermudagrass fairways and tees in central Florida, including but not limited to: weeds, diseases, insects and nematodes. Specifics are included below:

Weed Control - Pre and post emergence herbicides are planned for the control of grassy and broadleaf weeds. A large emphasis will be placed on preemergence herbicides as many of the grassy weeds in Florida are more easily controlled via preemergence herbicides as opposed to postemergence herbicides. The comprehensive preemergence herbicide program is outlined below for fairways and tees. This program is designed to control aggressive grassy weeds (goosegrass, crabgrass, tropical signalgrass, etc.). Aggressive postemergence applications for kyllinga and sedge species will be included since most preemergence herbicides have limited activity on these weed species.

#### Fairways and Tees

- January Prodiamine (trade name Barricade) at 0.75 lbs. ai/A
- February Oxadiazon (trade name Ronstar) at 3 lbs. ai/A + fertilizer
- May Oxadiazon (trade name Ronstar) at 3 lbs. ai/A + fertilizer
- July Prodiamine (trade name Barricade) at 1.0 lbs. ai/A + Sulfentrazone (trade name Dismiss) at 0.375 lbs. ai/A
- September/October No fall preemergence herbicide will be applied due to overseeding of tees to perennial ryegrass







Insect Control — Preventative applications of insecticides (registered by US EPA and state of Florida) are planned for control of mole crickets, grubs and fire ants. As mentioned previously, application of these insecticides will be based upon an IPM program of scouting and pest identification.

**PRIMARY BERMUDAGRASS ROUGH** — Similar to tees and fairways, the primary rough are established hybrid bermudagrass.


<u>Fertility</u> —The fertility program in the rough will be largely based upon slow release fertilizer technology such as polymer coated urea and organic fertilizer.



## Golf Course Superintendent

The superintendent is entrusted with the maintenance, operation and management of a golf course. He serves as the liaison between the company, the customer representative and the golf shop on matters concerning daily course operation. He shall be easily contacted and will, in turn, be in contact with the key employees on the golf course at all times. The superintendent must be able to respond quickly to any situation.

- Fulfill administrative duties timely. Administer all aspects of the BrightView Safety Program and the BrightView BV360 Management Program.
- Represent BrightView Golf Maintenance in a positive and professional manner including attitude, appearance and speech.
- Maintain effective employee and public relations.
- Meet or exceed external and internal customer expectations.

- Experience in all phases of golf course management and turf culture.
- A working knowledge of the construction, establishment, and maintenance practices employed on golf course putting greens, tees, fairways, roughs, and bunkers.
- A degree or advanced knowledge of agronomy, horticulture, plant or soil science. High degree of administrative and executive ability including effective oral and written communication skills and computer proficiency.
- Certified and /or licensed for pesticide usage.
- Familiar with the characteristics and proper use of fertilizers and soil conditioners. Knowledge of irrigation including watering practices, irrigation systems, pumps, wells and automatic controls and drainage.

The superintendent and assistant superintendent must be able to respond quickly to any situation.

- Supervise the operation, maintenance, and repair of all equipment assigned to the course.

- Manage golf course maintenance employees. Provide valuable inputs on the interview, hire, training, discipline and the separation process.
- Protect the company's interest through an awareness of and compliance with all applicable regulations including course and company policies. Fulfill administrative duties timely.
- Administer all aspects of the BrightView Safety Program and the BV360 Management Program
- Represent BrightView Golf Maintenance in a positive and professional manner including attitude, appearance, and public relations.
- Meet or exceed external and internal customer expectations.
