ORDINANCE NO. 210666

An ordinance of the City of Gainesville, Florida, amending Section 2-408 of the City of Gainesville Code of Ordinances relating to the Gainesville Community Reinvestment Area advisory board; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an effective date.

8 WHEREAS, the Municipal Home Rule Powers Act, Chapter 166, Florida Statutes, secures for

- 9 municipalities the broad exercise of home rule powers granted by Article VIII, Section 2 of the
- 10 Florida Constitution, including the exercise of any power for municipal purposes not expressly
- 11 prohibited by law; and
- 12 WHEREAS, at least ten days' notice has been given once by publication in a newspaper of
- 13 general circulation notifying the public of this proposed ordinance and of two public meetings
- 14 in the City Hall Auditorium located on the first floor of City Hall in the City of Gainesville where
- 15 any interested parties may appear and be heard; and
- 16 WHEREAS, public meetings were held pursuant to the notice described above at which
- 17 meetings interested parties and all others had an opportunity to be and were, in fact, heard.

18 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE,

19 **FLORIDA:**

20 **SECTION 1.** Section 2-408 of the City of Gainesville Code of Ordinances in amended as follows:

21 Sec. 2-408. – GCRA advisory board.

The city commission shall appoint a fifteen <u>nine</u> member GCRA advisory board to serve in an advisory capacity to the city commission on matters of community redevelopment within the GCRA. To the extent possible, members of the advisory board should reside or work within the GCRA and should be a demographically and educationally diverse representation of the <u>GCRA</u>. The advisory board should meet monthly and may adopt rules of procedure, subject to approval by the City Commission, to govern the conduct of its meetings. Staff support for the advisory board will be under the direction of the city manager. 29

30	SECTION 2. It is the intent of the City Commission that the provisions of Section 1 of this		
31	ordinance become and be made a part of the Code of Ordinances of the City of Gainesville,		
32	Florida, and that the sections and paragraphs of the Code of Ordinances may be renumbered or		
33	relettered in order to accomplish such intent.		
34	SECTION 3. If any word, phrase, clause, paragraph, section, or provision of this ordinance or		
35	the application hereof to any person or circumstance is held invalid or unconstitutional, such		
36	finding will not affect the other provisions or applications of this ordinance that can be given		
37	effect without the invalid or unconstitutional provision or application, and to this end the		
38	provisions of this ordinance are declared severable.		
39	SECTION 4. All ordinances or parts of ordinances in conflict herewith are to the extent of such		
40	conflict hereby repealed.		
41	SECTION 5. This ordinance will become effective immediately upon adoption.
