

## SUMMARY:

This item is a request for the City Commission to consider an application for a lien reduction or rescission for 1127 NE 22<sup>nd</sup> Ct, Gainesville, Florida. On February 20, 2020, the City Arborist referred to Officer Samantha Norris a compliant of a 26" Live Oak removed without a permit from this location. This is a violation of City Ordinance 30-8.9 B&C.

On July 10, 2020, a Special Magistrate Hearing on the matter obtained a Guilty verdict. The Magistrate allowed Mr. McCluney until September 10, 2021 to pay the tree mitigation fee of \$650 plus Administrative Costs of \$106.67, or be fined \$100 a day. The fees and costs were not paid and the property was out of compliance for 60 days, resulting in a lien of \$6,000 plus the above mentioned costs and fees.

On November 15, 2021, Mr. McCluney met with Sustainable Development Director, Andrew Persons and Neighborhood Enhancement Manager, Pete Backhaus to discuss the reduction/rescission of the lien. He advised that he had lost track of time and was dealing with health issues, resulting in his not paying the fees and costs when due. He would like the fines reduced to zero.

Based on the violation only affecting Mr. McCluney's property and his payment of the outstanding Administrative costs and Tree Mitigation Fees, the City concurs with Mr. McCluney's request to reduce the fines to zero and the Magistrate's recommendation of the reduction to zero.
