Keep Alachua County Beautiful is a non-profit organization that strives to involve local residents and businesses in keeping our community clean, healthy, and a beautiful place to live. Our programs are inclusive and have helped build relationships between populations of different incomes, education, culture, gender and age. We began our mission 30 years ago and have established ourselves as a vital factor in the state of our local cities and county.

By working to eradicate blight in terms of litter and graffiti, the economic stability of our community has improved but we are not done yet. A clean and healthy community has attracted business investment and furthered the expansion our academic and medical communities. Alachua County is able to attract the best and the brightest in all professions because we have created an environment that projects a high level of engagement on health, safety and sustainability overall. Our immediate task of hosting daily cleanup events daily is a constant prompt for individual responsibility toward improving our community. We engage a cross-section of the local community around an issue everyone can agree on which allows bridges to be built between people from different walks of life and different demographics. This activity encourages people not to litter and instead dispose of trash properly and take the next step to recycle and reuse to reduce the amount of trash generated. Our community consistently receives the highest score, a "1", in the annual Community Appearance Index, a science-based assessment of our progress.

KACB usually recruits 3,000 to 5,000 volunteers each year. Last year alone, these volunteers return 15,648 hours of community service, removed 411,920 lbs. of litter, and 5,947 lbs. of recyclables including

used tires. Due to COVID-19, we had only 3,003 volunteers last year and we hope to use this grant to return to pre-pandemic levels of volunteers. These activities also build an appreciation for the natural environment and environmental concerns.

We also installed four new community gardens, planted over 8,000 trees and pollinator plants, and removed 250-300 incidents of graffiti each month. All of these projects are part of our annual Great American Cleanup events series.

Our community garden and edible groves programs improve food security for our most vulnerable populations and bring neighbors together to help each other.

Our after-school environmental education program each week provide 20 to 30 youths with a constructive activity and a creative outlet. The lessons teach youths about our natural environment and help them to build self-esteem and improve their academic skills in a non-threatening environment. The children engage in outdoor cleanup and gardening activities to improve their physical and mental health, as well as their immediate environment.

Pandemic changes to your organization

Pandemic-related changes to priorities and goals*

Briefly explain how the COVID pandemic has changed your organization's priorities and goals.

Our priorities have shifted toward focusing our service on assisting our more vulnerable populations. With people quarantined, we pivoted to providing food production-related resources to people and socially-distanced outdoor activities to help people feel less isolated. Using more internet offerings, including webinars, we were able to reach even more people in quarantine and rural areas of our county.

An increased emphasis on food security meant shifting our resources more toward community gardens and edible groves. By partnering with the Strong Roots Movement, we were able to increase the capacity of our organization to provide technical gardening assistance. We partnered with the City of Gainesville to provide KACB volunteers to assist with pruning, fertilizing and watering the newly established fruit and nut tree "edible groves,"

Our outreach also shifted toward giving residents supplies longer term and even to keep so they could continuously engage in cleanup activities.

Large area projects were also prioritized to allow volunteers to have a big impact while socially distancing themselves to stay safe. One project allowed for 2,000 long leaf pines to be planted in a single day on conservation lands. This planting will help establish this native plant species. From this experience, we are already scheduling more large-scale events.

The pandemic situation also reiterated the value of our partnerships with other like-minded nonprofit organizations. We reached out during COVID-19 and continue to build on these relationships by assisting our partners with the submission of grant proposals. Our executive director was a grant specialist for IFAS in the 1980s and has managed grants for the City of Gainesville and other organizations for over 40 years. She uses this expertise to help our partners which in turn builds the capacity of our organization to recruit members, volunteers and even board members.

Pandemic-related changes to your organization's operations*

Please describe how your operations have changed during the pandemic from a staffing and service delivery standpoint.

We have a desperate need for permanent staff. Prior to the pandemic, we relied on interns and volunteers to coordinate our volunteer activities and teach our environmental education lessons. Because of the pandemic, our staff turned over drastically and we came to the conclusion that we need to recruit and train new, permanent staff to take on these responsibilities. A well-trained, more permanent staff will not only help us to build membership capacity but also to ensure we stay focused on our longer term objectives, especially our environmental education programs. These programs are essential to getting and staying ahead of litter and graffiti problems; it is much more efficient to prevent litter from happening than to try to remove litter from roads and waterways.

Since we also go into the communities that are most at risk, increased staff and resources are required to meet this need. We also realized professional litter crews are needed to reach less densely populated areas. To this end, we are working to identify additional stakeholders including the University of Florida, the tourism bureau "Visit Gainesville," and smaller municipalities to join forces with KACB, the City of Gainesville, and Alachua County in an effort to effectively and consistently remove litter from throughout the city of Gainesville and Alachua County.

We also plan to host more online offerings and are working to recruit support for building a recording studio. Brevard County had the first studio of its kind and we hope to establish one here so we can reach out to businesses, residents, and visitors, even during a pandemic.

Impact

Description of Need as Specifically Related to Coronavirus*

We need additional supplies and staff. More permanent staff is needed to handle online scheduling of volunteers, to check supplies in and out, and compile data for reports to funding agencies. Many of our supplies need to be replaced as they went home with University of Florida students when campus shut down and did not return (we can only hope they were used back home). We also need to produce more distance-learning opportunities regarding gardening and zero-waste activities, especially for our youth.

The State of Florida did not provide funding for the past two years. Before the pandemic, \$15,000 or \$16,000 was provided each year to Keep Alachua County Beautiful and other local affiliates of Keep Florida Beautiful. Grants of \$10,000 and 20,000 from Keep America Beautiful, the national organization with whom we are also affiliated, were awarded before the pandemic but have been drastically scaled back or eliminated now. We know we will need to identify new funding sources just to maintain our current level of effort.

Alachua County has expressed an interest in funding a zero-waste project soon and these funds along with support from new stakeholders and funding agencies will be used to sustain our long-term program.

Chris Polischuck: It is difficult to see this request qualifying for an ARPA grant award. The linkage between increased litter and the pandemic is tenuous at best (it could simply be from increased traffic), and while there is a portion of programming aimed at mitigating food insecurity (the community gardens), it appears as more of a sideline activity, rather than the major objective of the agency.

The request could possibly qualify under 2.10 Aid to nonprofit organizations, but the applicant did not submit a revenue loss calculation, and the financials show just a small (\$1,036) negative net income.
