Pandemic changes to your organization

Pandemic-related changes to priorities and goals*

Briefly explain how the COVID pandemic has changed your organization's priorities and goals.

The pandemic created a crisis of inequitable access to information, COVID mandates, services, and care for Latino communities, the main focus of our work. Local COVID information and linkage to services in Spanish have been rare and other languages have been near non-existent. This became clear from the countless calls from partners, social services, and community members who were looking to our Spanish-language community engagement program, Project SALUD, for guidance.

Although based in Gainesville for 30 years, our pre-pandemic focus had been in Marion and Levy Counties, coordinating Community Health Worker programming, parent engagement workshops for ESOL families and in Alachua, our annual coordination of (15 years!) health fairs for blueberry/watermelon farmworkers. With the onset of the pandemic, our work drastically shifted, expanding our outreach by 50% to Gainesville, with laser focus on COVID response. Since then, we have been producing and distributing urgent health messaging and coordinating COVID testing and vaccine services, with health systems, for monolingual Spanish-speakers. In recognition of the local increase of Mayan indigenous speakers, we develop COVID-related audio /video formats in the 3, mostly spoken, indigenous languages.

Our program, Project SALUD, expanded its role as the "community resource hub" in Gainesville for Latinos, managing 295 calls for local referrals and assistance, linking Spanish-speakers and partners to accurate COVID information, PPE, emergency food and medical monitoring for hundreds of farmworkers entering Gainesville over the pandemic.. The expanded workload led to hiring of a full-time Referral Coordinator.

To meet critical needs, we initiated VIVIR-21, under Project SALUD; a collaboration with UF/Equal Access Clinic and Florida Legal Services to assist with all COVID issues, resulting-to-date: 40 medical monitoring cases, over 800 COVID vaccines, 18 home visit testing teams for families, 50 test referrals.

We initiated Community Health Worker programming into Gainesville to meet critical demands. CHWs are a linkage point for over 300 new medical and social service cases managed since September of 2019. To further increase our local reach during the lockdown, we hired 11 lay, community-based Outreach Workers. We responded to demands for masks (distributing 5500 cloth masks in the first 6 months and 3000 KN95/surgical masks to community members and partners via our health workers, at health fairs, and food distribution.

Additionally, we added a dedicated, full-time Language Access Advocate in Gainesville pushing agencies' compliance with the Civil Rights Act of 1964, Title VI in the provision of pandemic information, test/vaccine events and interpretation at COVID events-- in languages other than English. To bolster this work, the RWHP serves as the Co-Lead for the City of Gainesville's GINI- Immigrant Neighbor Inclusion Initiative, to address immigrant equity, inclusion, and safety.

Pandemic-related changes to your organization's operations*

Please describe how your operations have changed during the pandemic from a staffing and service delivery standpoint.

Operations switched to mostly virtual for a full year. Expansion of staff hired to meet new Gainesville work in the outside region, increasing full-time staff from 2 to 5, increased part-time staff to 3. Engaged 11 Outreach workers and 3 Community Health Workers to directly serve 830 monthly. We increased the training of: UF medical student home visitors on COVID monitoring, COVID testing procedures, universal precautions, and CHW's linkage to vaccinations, resources, and working with indigenous speakers. We onboarded a graphic artist and translation consultants in indigenous Mayan languages, and Haitian Kreyòl.

Direct relief services: As the community became desperate for PPE, we contracted a seamstress to produce cotton masks for adults and children, then shifted to purchasing surgical/NK95 masks. Food insecurity increased we coordinated food donations, before acquiring two, one-time, grants to purchase/distribute 13,000 pounds of bulk food via 6 partners. Hygiene /diaper product needs prompted the coordination of local funding drives, food and medicine delivery, funeral funds, and volunteer coordination. One-time funding was obtained to support equitable response to food insecurity and the PPE mask seamstress. Non-renewable funds were obtained in year one for educational material development and translation.

We have contracted indigenous language assistance for Mam, Q'anjob'al, Akateka, and Mixteco Alto to assure a quick turnaround for print/audio translation and to provide interpretation at medical appointments in Gainesville. Translation (including Spanish) needs have increased to a point where it is no longer viable for us to translate promotional materials or interpret intake forms for such partners as Equal Access Clinic, Prenatal Night, World's Greatest Baby Shower, Farm Share partners, Library Partnership, etc. To reduce our load and increase partner responsibility and capacity, we have hired a full-time Coordinator to focus on language access advocacy with the city, county, nonprofits, and safety net providers. To meet local agency request, we will collaborate with Language Access Florida to facilitate free "Language Access Institutes" to Gainesville agencies, upon funding.

Increased numbers of case management, via Project SALUD, within Gainesville alone required a full-time coordinator to serve 300/year. To coordinate the increased client needs for linkage to care and financial assistance to navigate hospital payments, we have had to upgrade to a fully HIPPA compliant data management system, which is efficient, but costly. It has been critical to hire a part-time Data Manager to support our referral teams.

Lastly, we now coordinate an expansive Health Worker Team in Gainesville, providing timely information, education topics, and resources to over one thousand Spanish speakers. This requires a dedicated Coordinator to oversee training, data management and preparation of educational materials on a monthly basis.

Impact

Latino communities are highly vulnerable to COVID due to language challenges, lower vaccination rates, living in shared housing, working essential labor, often in close quarters. Therefore, we need to maintain Project SALUD Referral Services/ VIVIR-21 COVID assistance, outreach and linkage to services. CHW/Outreach teams embedded in their communities help reduce exclusionary service realities that reduce non-English speakers access. We believe it is imperative to continue to provide confidential and reliable services. As we have won the confidence of this community, comfort in seeking services continues to increase. So, dissemination of our annual magazine "Su Salud" fills the void of minimal Spanish media, linguistically and culturally viable educational materials will assure clear, factual COVID and health information is available. Providing "Language Access Institutes" to area agencies will reduce exclusionary practices impacting immigrants. A "Community Resource Guide" in Spanish and other languages will provide guidance to immigrants on their rights, locating community services, English classes and legal services to build their inclusion. Continuation of advocacy work to build recognition of diverse community needs.

As our one-time COVID funds dry, ongoing COVID and other critical support continues to be needed as our community (government/agencies) build language access competence and immigrants have equitable access to information and services. As we enter our 31st year, commitment to health justice for Latinos continues.

The RWHP has obtained funding from foundations, government agencies and corporations for over 30 years. Assuring funding requires work with collaborating organizations in order to maximize funding streams. And to reach the goals outlined, we will continue these strategies.

But, we do believe that attention spent building the capacity of other services to serve multilingual neighbors (Language Access Institutes) and provide tools for immigrants and limited English speakers to learn how to access services (Community Resource Guide), improve their English and raise the attention of the community to the work yet to be done around health equity, funding will not be need to support our programming to the current extent. Our goal is to build the infrastructure for equitable systems via information and training as the sustainable aspects of this work. For this reason we place emphasis on training community based health and outreach workers who are seeds planted in needing communities.
