Gainesville Circus Center, Inc is a 501c3 non-profit social circus and a licensed childcare facility through the Department of Children and Families. Our mission is to build community through quality instruction and performance of circus arts. As a social circus, we aim to provide circus arts experiences to all, especially atrisk youth, who stand to benefit the most from circus arts. We understand "at-risk youth" to be those facing disadvantages due to socioeconomic status, race and gender.

Circus arts have the power to build strength on physical, emotional and mental levels and to promote cross-cultural and inter-generational collaboration. From aerial silks to trapeze to group acrobatics, Gainesville Circus Center is dedicated to teaching circus arts to anyone willing and interested in learning for the purpose of bettering their physical, mental, social and spiritual self.

Gainesville Circus Center serves our community by providing childcare for 132 kids in our youth circus program. Our youth circus program includes 180 days of afterschool childcare and 50+ days of school-holiday camps. We provide transportation from local public schools to facilitate participation from low-income families. The schools we provide transportation from are: Parker Elementary, Talbot Elementary and Resilience Charter school. Our program consists of 60% scholarship students from low-income families.

Additionally, the Gainesville Circus Center engages in community outreach. Our youth and adult programs collaborate often to bring circus arts experiences to our community partners. You will find our members performing at local events and public schools, such as: Gainesville Downtown Festival & Art Show, 5th Avenue Arts Festival, Sidney Lanier Public School, Rawlings Elementary School, TEDxUF, and Active Streets Alliance, to name a few.

The pandemic forced our organization to improve the quality of our services, safety and efficiency. The Gainesville Circus Center has invested much of its resources over the last 2 years in maintaining high-quality staff to implement our programs. Safety has always been a high standard for our program, but now Covid-safety has added multiple layers of checks and balances to this factor. Efficiency has been key to streamlining our processes and making sure we do not waste valuable resources, whether it's time or money.

Pandemic-related changes to your organization's operations*

Please describe how your operations have changed during the pandemic from a staffing and service delivery standpoint.

The Gainesville Circus Center has numerous new safety protocols to combat the pandemic. The first and most obvious is sanitization. Our staff sanitize equipment after every class. This adds cost in both the form of time and materials. We contracted a sanitization company to fog our facility on a monthly basis with the Clorox 360 Electrostatic Disinfection system and have a more frequent schedule of washing any fabric equipment used in our classes. Lastly, all of our staff and clients use masks in the facility. This will continue as long as the CDC deems our county to be high risk.

Maintaining a highly trained work force is an important component to any successful business. The volatility of staff scheduling has been tremendously difficult to manage with limited staff available. Most of our staff work part time, so changes in their primary jobs have also greatly impacted their ability to work with us. This situation has caused us to seek out more trainees than we normally would have, so that there are always 2-3 up and coming staff members to step in as needed. Staff training for our unique discipline is also a lengthy and expensive process.

Typical staff must be in good physical condition and undergo 6 months – 1 year of training in circus arts to work with any of our programs. They must pass our 30-hour in-house teacher training program if they do not hold a teaching certificate already. Additionally, they must complete 40 hours of childcare training with the Department of Children and Families and maintain on-going staff training with DCF and with GCC. GCC provides monthly staff training sessions to improve our staff and enhance our productivity as a team. Furthermore, all staff must be CPR/First-Aid certified and pass a level 2 background check.

The pandemic forced the Gainesville Circus Center to close from our original location. We were able to reopen with support from emergency funding, however, the move into a new facility carried its own costs. The new facility is more expensive than the original one, and new equipment had to be purchased to fit the space.

One more new feature of our operations directly related to the pandemic is our reservation and cancellation policy. We require reservations for our classes, which have limited availability. Cancellations within 24 hours of the class are considered forfeited (no refund) no matter what the reason. If no one has made a reservation for a class within 24 hours of the class start time, the instructor maintains the right to cancel the class. Since we use an app for registrations and scheduling, clients can see the schedule on their phones and sign up for class (or see that it has been cancelled). Although many clients complain about this procedure, it has been essential to prevent teachers from showing up to teach no one, and/or losing money on classes by people who cancel last minute.

In the last year and a half, the Gainesville Circus Center has developed a relationship with the Children's Trust of Alachua County (CTAC). The Gainesville Circus Center hold 3 grants from the CTAC: After school Program Grant, Summer Camp Grant and Youth Development Capacity Building Grant. These grants have allowed us to provide scholarships for at-risk youth in our community and support our on-going staff training and community networking. Gainesville Circus Center also has support from the Florida Division of Arts & Culture and Visit Gainesville.

As we recover and rebuild our program, we are attracting new clients and opening up new service hours as we are able to staff them.

I do not have access to the 2020 balance sheet, because we were using a different software at that time, and I no longer have a subscription to that software. I have included our 2020 990 filing in place of a balance sheet.

The allocation of funds was determined by dividing the total request up evenly over the 46 month period in review. Therefor, each month represents \$22,628.37. This number was multiplied by the number of months requested in each section above, for a total request amount of \$1,040,905.03.

Our board of directors meets on a monthly basis and reviews financial reports at this time. Financial reports are created through the "Statement of Activity" tool in quickbooks.

It should be noted: Quickbooks has been calculating the director's paycheck twice, creating an unrealistic deficit of over \$47,150 for 2021. This issue has been reviewed by more than one accounting professional who have recommended using a different software (i.e. unable to solve the glitch). The correct net income (loss) for 2021 should be -\$41,944.00.

Chris Polischuck: The Final Rule defines examples of eligible childcare services as traditional daycare centers and schools providing after-school programs. It is unclear whether the type of after school "childcare" provided by Circus Kids would qualify under ARPA guidelines. In addition, more information would be needed to determine if low-income families served by the program met Treasury income guidelines.

However, the agency itself demonstrated an income loss of \$55,167 due to the effects of the pandemic and is eligible for an ARPA award of up to that amount.
