The proposed Ordinance is submitted to implement and amend the appropriate sections of the

Land Development Code to reflect the Charter Amendment, Ordinance #191051 and Resolution #200500.

The modification is to amend the existing ordinances as referenced above and change the title of

"Clerk of the Commission" to "City Clerk". The history is stated below:

Certified Cashiers Receipt:

The Gainesville City Commission approved a proposed charter amendment to re-title the Clerk of the Commission to City Clerk
this action requires an ordinance modification to the following sections: 30-3.3, 30-3.4, 30-3.37, 30-3.39, and 30-10.8 of the
Land Development Code (Chapter 30 of the City of Gainesville Code of Ordinances), which currently references Clerk of the
Commission. The City Commission directed that a proposed charter amendment to change the name of the charter officer
"Clerk of the Commission" to "City Clerk" be submitted to the electors for approval or disapproval at the November 2020
election. The City Commission then adopted Resolution No. 200500 which adopted the report of the
Alachua County Board of Canvassers for the City of Gainesville election held on November 3, 2020, which report showed
that the City Charter Amendment to change the name of the charter officer "Clerk of the Commission" to "City Clerk" passed.
The proposed Charter Amendment Ordinance, #191051 is submitted to implement the above action; an amendment to
3.04 titled "Clerk of the Commission" of the Charter Laws of the City of Gainesville to the charter name "City Clerk" of the
Charter Laws of the City of Gainesville.
