WHEREAS, the City of Gainesville is required by Section 163.3202, Florida Statutes, to adopt or

amend and enforce land development regulations that are consistent with and implement the

Comprehensive Plan and that are combined and compiled into a single land development code

WHEREAS, the City of Gainesville Land Development Code (Chapter 30 of the City of Gainesville

Code of Ordinances) establishes zoning districts to implement the Comprehensive Plan and

WHEREAS, this ordinance, which was noticed as required by law, will amend the Zoning Map



 - See legal description attached as **Exhibit A** and made a part hereof as if set forth in full. The location of the property is shown on **Exhibit B** for visual reference. In the event of conflict or inconsistency, **Exhibit A** shall prevail over **Exhibit B**.
- SECTION 2. The City Manager or designee is authorized and directed to make the necessary changes to the Zoning Map Atlas to comply with this ordinance.
- 52 **SECTION 3.** If any word, phrase, clause, paragraph, section, or provision of this ordinance or 53 the application hereof to any person or circumstance is held invalid or unconstitutional, such


- finding will not affect the other provisions or applications of this ordinance that can be given 54 effect without the invalid or unconstitutional provision or application, and to this end the 55 provisions of this ordinance are declared severable. 56 SECTION 4. All ordinances or parts of ordinances in conflict herewith are to the extent of such 57 conflict hereby repealed. 58 SECTION 5. 
