GNVRise

- Fall 2018 Drafting revisions to Land Development Code: In response to growing concern about housing affordability, supply, and accessibility within the City of Gainesville in the fall of 2018, the City began working on revisions to the Land Development Code to promote greater zoning flexibility to spur housing development.

ImagineGNV Comprehensive Plan Update

ImagineGNV is the process the City of Gainesville has taken over the past year to updated the City's Comprehensive Plan. This plan is the City's 10 year vision that determines what can be built where, how public dollars are spent, and nearly every aspect of life in Gainesville. ImagineGNV is an effort to update the plan together with the community members who have not historically had a seat at the table and address the impacts of systemic racism historically and today.

- March 30, 2021 Imagine GNV Listening Session on Racial Equity: City staff hosted a listening session on Zoom where neighbors were invited to hear a brief presentation on the Comp Plan, followed by an overview of current ideas for the updated Plan, and open discussion about how the City can plan for an equitable future. The focus of this session was on Racial Equity in Gainesville.
- **April 6, 2021 Imagine GNV Listening Session on Housing Justice:** City staff hosted a listening session on Zoom where neighbors were invited to hear a brief presentation on the Comp Plan, followed by an overview of current ideas for the updated Plan, and open discussion about how the City can plan for an equitable future. The focus of this session was on Housing Justice in Gainesville.
- April 8, 2021 Imagine GNV Listening Session on Economic Justice: City staff hosted a listening session on Zoom where neighbors were invited to hear a brief presentation on the Comp Plan, followed by an overview of current ideas for the updated Plan, and open discussion about how the City can plan for an equitable future. The focus of this session was on Economic Justice in Gainesville.
- April June 2021 Community Cultivators Program: 10 community members where hired as paid Fellows to support the ImagineGNV process. These individuals met 2 3 times per week over 3 months to learn and co-develop a curriculum on the basics of development and comprehensive planning, as well as an engagement project that would reach the boarder community. The Fellows also reviewed and provided feedback on the drafted chapters of the Comprehensive Plan.
- May June 2021 Conversations in a Box: A kit was prepared to serve as a guide for neighbors to bring together a small group of friends, family or neighbors to discuss important community issues for the purpose of influencing the Comprehensive Plan Update. The Conversation in Box kit served as a conversation guide with question and instructions. The kit was shared with numerous faith based groups, community organizers and members of the City Commission. Feedback was received from over 50 community members.
- **April December 2021 Konveio Website:** To increase transparency and engagement in the drafting of the Comp Plan, the ImagineGNV process included using a website where drafted chapters of the Comp Plan updated were posted, revisions were regularly uploaded, and the public had the ability

- to comment directly on the draft. The site was shared with over 5000 people via social media, mailing lists and GNV news. Over 70 community members interacted with the Konveio site.
- January December 2021 16 Public Meetings: Public meetings of the City Commission (9), City Plan Board (4), Historic Preservation Board (2), and Joint City / Alachua County School Board (1) occurred. These meetings provide opportunities for the public to voice feedback and/or concerns around the Comp Plan Update.
- January December 2021 1-on-1 Meetings: Opportunities for individual conversation to address questions about development and comprehensive planning were made available to any individual or group that expressed interest. Over 10 1-on-1 meetings have occurred with faith groups, individual community members, Community Cultivators and staff.

Current Inclusionary / Exclusionary Zoning Process

- August 31, 2020 Special Meeting of City Commission (Virtual): Commission requested that staff begin the development of an inclusionary zoning (IZ) program and conduct a review of potential exclusionary zoning provisions contained within the City's Land Development Code. The referral was part of a multi-part motion intended to further the City's equitable development goals through a variety of policy and programmatic strategies.
- **February 18, 2021 HR&A Advisors was engaged by the City of Gainesville:** Consultant hired to analyze the causes of and potential strategies to address housing instability and racial inequities and develop a report and recommendations based on the study's findings. This study responded to the following guiding questions:
 - 1. What drives housing instability and inequities in Gainesville?
 - 2. How do exclusionary land use controls drive local housing market trends.
 - 3. How can changes to exclusionary land use controls make housing in Gainesville more equitable?
 - 4. Is an inclusionary zoning policy a feasible and effective tool for producing new affordable housing in Gainesville?
 - 5. What other programs and policies are needed to address housing instability and inequities?
- January 6, 2022 City Commission Meeting: The final report from HR&A was presented to the City Commission. The City Commission directed staff to prepare amendments to the code to implement the recommendations in the report for both Exclusionary Zoning items and an Inclusionary Housing ordinance by a unanimous vote of 5-0, with Duncan-Walker absent.
- **February 24, 2022 Public Hearing with City Plan Board:** First public hearing regarding proposed code amendments.
- March 31, 2022 Public Hearing with City Plan Board: Second public hearing regarding proposed code amendments. The item was continued to the June 23, 2022 meeting to give time for the City Commission housing workshops to occur before taking final action on their recommendations. Subsequent to that meeting, the City Commission discussed the timing of workshops and then directed the Plan Board to take up the item at their 5-26-22 meeting. Due to issues surrounding COVID, the workshop timing was shifted to 6/1 and 6/4 thereby necessitating the Plan Board to shift their consideration of the items to a special meeting scheduled for 6-6-22.
