## ORDINANCE NO. 211145 1 An ordinance of the City of Gainesville, Florida, amending 2 Sections 4-1 and 4-4 of the City Code of Ordinances relating to 3 the sale, dispensing, possession and consumption of alcohol; 4 amending Section 18-20 of the City Code of Ordinances relating 5 to the purchase or sale of alcohol in parks; and amending 6 Section 2-339 of the City Code of Ordinances relating to civil 7 citation for the possession or consumption of an open container 8 9 of an alcoholic beverage; providing directions to the codifier; providing a severability clause; providing a repealing clause; 10 and providing an effective date. 11 12 WHEREAS, the City Commission adopted Ordinance No. 200250 to suspend 13 enforcement of the City's open container prohibitions during the COVID-19 pandemic; 14 and: 15 WHEREAS, the City Commission found that there was not any substantial increase in 16 crime or public disorder during the original time period of suspension of enforcement of the 17 City's open container prohibitions during the COVID pandemic; and 18 WHEREAS, the City Commission adopted Ordinance No. 210005 which amended the 19 City's open container prohibitions post-COVID pandemic to limit only the hours the prohibition 20 would be in place; 21 22 WHEREAS, the City Commission finds that there has been a substantial increase in crime or public disorder during the time period since the passing of Ordinance No. 210005, in 23 part due to allowing open consumption and possession of open containers of alcohol on City 24 25 properties and right of ways, and believes that the reinstatement of the original open container prohibitions are necessary for public safety reasons; and 26 27 **WHEREAS**, the City Commission wants to prohibit the public possession of open


containers and consumption of alcohol on city property and public right-of-way on a permanent

15	Chapter 4 – A	ALCOHOLIC BEVERAGES		
16	Article I. IN	GENERAL		
17	Section 4-1. I	Definitions		
18	(a)	The definitions contained in the beverage law of the state, as defined in F.S. chs.		
19		561, 563 and 564, and interpreted by the courts of this state and the state director		
20		of the division of alcoholic beverages and tobacco of the department of business		
21		and professional regulation, shall apply to the terms in this chapter.		
22	<u>(b)</u>	Open container shall mean any bottle, can, glass, cup or other vessel, other than		
23		the original unbroken sealed container or a bottle of wine, beer or liquor, resealed		

1	pursuant to F.S. § 561.20(2)(a)4., 564.09 or F.S.S. 565.045, provided however,		
2	that if a bottle of alcoholic beverage is resealed pursuant to F.S. § 561.20(2)(a)4.,		
3	564.09 or F.S.S. 565.045, is transported in a motor vehicle, the resealed bottle		
4	shall be considered an open container unless it is placed in a locked glove		
5	compartment, a locked trunk, or the area behind the last upright seat of a motor		
6	vehicle that is not equipped with a trunk.		
7	(c) Alcohol event permit means a permit issued pursuant to section 4-4 of this Code		
8	that allows the temporary sale of beer, wine or other alcoholic beverages.		
9	(d) Not-for-profit entity means an entity qualified under Section 501(c)(3) of the		
10	Internal Revenue Code and registered pursuant to F.S. ch. 496.		
11	<b>Section 2.</b> Section 4-4 in Article I of Chapter 4 of the Code of Ordinances of		
12	Gainesville, Florida is hereby amended to read as follows:		
13	Chapter 4 – ALCOHOLIC BEVERAGES		
14	Article I. IN GENERAL		
15	Sec. 4-4. Sale, and dispensing, consumption and possession generally.		
16	(a) Generally. Except as specifically allowed by this section, it shall be unlawful for any		
17	person to sell, distribute, consume or possess any alcoholic beverage in any open containe		
18	on any property owned by the city, including city owned parking lots and city owned		
19	parking garages, or on any public right-of-way, including without limitation, streets		
20	thoroughfares, highways or sidewalks, Any person or legal entity that is allowed to sell o		
21	dispense alcoholic beverages pursuant to this section shall comply with all applicable		
22	federal, state and local laws related to the sale or dispensing of alcoholic beverages. The		

- city manager is authorized to promulgate written administrative procedures to implement this section and any alcohol event permits authorized herein.
  - (b) City-owned property, parking lots and parking garages. It shall be unlawful for any person to sell, or dispense, possess or consume any alcoholic beverages on any property owned by the city, including, but not limited to, city owned parking lots and garages at any time, or consume or possess any alcoholic beverage in any open container between the hours of 2:30 a.m. 11:30 p.m. and 8:00 a.m. each day, except as follows:
    - (1) At the airport terminal facility and the municipal golf course facility when being sold or dispensed by the facility owner or by a natural person or legal entity that is under contract with the facility owner;
    - (2) Within the rental event space at the Thomas Center, the Thelma Bolton Center, Boulware Springs, and the Senior Recreation Center, dispensing, but not sale, for consumption during an event for which the space is rented. A fundraising event sponsored by a governmental or other public entity or a not-for-profit entity that charges admission for the event, but does not charge for the purchase of the alcoholic beverages, is not considered the sale of alcoholic beverages. The rental agreement may specify such terms and conditions as may be required by the city in its sole discretion as owner of the property.
    - (3) During a special event produced by the city, pursuant to written policy of the city. The city manager is authorized to promulgate a written policy to govern the process and contract terms and conditions under which the city may select not-for-profit entities to sell or dispense alcoholic beverages during a city produced special event.

- (4) On other property that the city makes available for special events produced by private parties, pursuant to written policy of the city. The city manager is authorized to promulgate a written policy to govern the process and terms and conditions under which the city may issue an alcohol event permit for the sale, or-dispensing, consumption or possession of alcoholic beverages on particular parcels of city-owned property. The city commission shall determine which particular parcels, if any, are made available for such events.
  - (5) On property that is leased to a private party pursuant to the city's real estate policy, if the sale, dispensing, possession and consumption of alcoholic beverages is expressly allowed under the terms of the lease agreement. The lease may specify such terms and conditions as may be required by the city in its sole discretion as owner of the property.
- (c) *Public right-of-way*. It shall be unlawful for any person to sell, or dispense distribute, consume or possess any alcoholic beverage in any open container on any city or other public right-of-way, including without limitation, streets, thoroughfares, highways or at any time, or consume or possess any alcoholic beverage in any open container between the hours of 2:30 a.m. 11:30 p.m. and 8:00 a.m. each day, except as follows:
  - Within a sidewalk café that is licensed in accordance with the city's Land Development Code.
- 19 (2) At an outdoor event, within the downtown district as shown in Figure 1, pursuant to an alcohol event permit.

The city manager, or designee, is authorized to issue an alcohol event permit for the sale of beer and wine associated with an outdoor event organized, produced and managed by a governmental or other public entity or a not-for-profit entity, subject to the following:

An alcohol event permit application must be submitted by the event organizer, on the a. form provided by the city, along with payment of the fee set forth in Appendix A of this Code.

- b. The alcohol event permit application shall include a site plan sketch showing the location, access, barriers delineating the event site from other public areas and all other pertinent details of the site; a report detailing the dates and times during which the event will be conducted, the estimated number of people expected to attend, the capacity of any proposed temporary structures, the capacity of the event site, whether there will be outdoor entertainment, a plan for the installation of temporary sanitary facilities, a plan for the storage and pickup of solid waste during and after the event; and a public safety plan detailing how the applicant will maintain crowd control and public safety, and comply with Chapter 15. Noise of this Code.
- c. The alcohol event permit application shall be reviewed by the appropriate departments of the city to ensure protection of the public health, safety and general welfare. In addition to normal concerns of each such department, particular attention will be given to traffic flow and control, auto and pedestrian safety, noise and the effect that the use and activity will have on surrounding uses, particularly where the adjoining or nearby use is residential.
- d. The alcohol event permit may be approved or denied by the city manager or designee based on compliance with this subsection. The city manager or designee may impose additional special conditions as deemed necessary to protect the public health, safety and general welfare.
- e. Only two alcohol event permits may be issued per calendar year per applicant.

  However, one alcohol event permit may include all of the University of Florida home football games for the school year.

1	f.	Each alcohol event permit issued shall be subject to the following conditions,		
2		requ	requirements and limitations, as well as any other special conditions stated in the	
3		per	permit.	
4		1.	A sufficient number of off-duty law enforcement officers and fire-rescue	
5			personnel, as determined by the city, shall be employed by the permittee to	
6			provide security, crowd control and emergency medical services for the event.	
7		2.	The permittee shall indemnify the city, its elected and appointed officers,	
8			employees, and agents from any claim for personal injury, including death, or	
9			property damage, including destruction, associated with the event. This	
10			indemnification shall be in the form of an insurance policy acceptable to the	
11			city's risk manager, that names the city as an additional insured and is endorsed	
12			to provide a separate aggregate of a minimum of \$1,000,000.00 for the event. In	
13			addition, the permittee shall procure a liquor liability policy with not less than	
14			\$1,000,000.00 of coverage that also names the city as an additional insured.	
15		3.	The event may only be held on such streets, sidewalks and rights-of-way as the	
16			city deems appropriate for temporary closure in its sole discretion.	
17		4.	The event may be open to the public only during such hours as the city deems	
18			appropriate in its sole discretion. Each event shall be limited to a maximum of	
19			72 consecutive hours, inclusive of time for set-up and clean-up.	
20		5.	The sale, dispensing and consumption of beer and wine shall occur only within	
21			an area secured by fencing or barricades that are a minimum of four feet in height	

and with limited points of entry and exit. The permittee shall not allow alcoholic

beverages purchased outside of the event to be brought into or consumed inside

1	the permitted event area. Nor shall the event organizer allow beer or wine sold			
2	inside the secured area to be taken out of, or consumed outside of, the secured			
3	<u>area.</u>			
4	(d) Outdoors on property owned by parties other than the city. It shall be unlawful for any			
5	person to sell any alcoholic beverage in an open container outdoors on any property owned			
6	by a party other than the city, except as follows:			
7	(1) Within an outdoor seating area that is part of an approved use of property which is zoned			
8	and permitted for the consumption of alcoholic beverages.			
9	(2) On property owned and managed/operated by the State of Florida, University of Florida,			
10	Santa Fe College or Alachua County, provided the state, university, college or the county			
11	(as applicable) ensures the protection of the public health, safety and general welfare. In			
12	particular, attention should be given to traffic flow and control, auto and pedestrian safety,			
13	noise and the effect that the use and activity will have on surrounding uses, particularly			
14	where the adjoining or nearby use is residential.			
15	(3) At a temporary outdoor event on property that is located in a zoning district where sale,			
16	distribution, and consumption of alcoholic beverages is permitted, as classified in the			
17	city's land development code; or at a temporary outdoor event on property that is zoned			
18	planned development (provided the planned development ordinance allows commercial			
19	or mixed-uses and not solely residential uses); or in connection with a temporary sale for			
20	fundraising by a nonprofit agency. Any such events shall require an alcohol event permit			
21	issued by the city manager or designee as follows:			
22	a. All alcohol event permit applications shall be submitted by the event organizer to the			
23	city, on the form provided by the city, along with payment of the fee set forth in			

- Appendix A of this Code. If the event is conducted within common area, the applicant must obtain the written consent of the owner(s) or manager (if the owners utilize a manager for such purposes) of the common area on the permit application.
- o. All alcohol event permit applications must include a site plan sketch showing the location, access, barriers delineating the temporary sale from other public areas and all other details of the site; a report detailing the dates and times during which the event will be conducted, the estimated number of people expected to attend, the capacity of any proposed temporary structures, the capacity of the event site, whether there will be outdoor entertainment, a plan for the installation of temporary sanitary facilities, a plan for the storage and pickup of solid waste during and after the event; and a public safety plan detailing how the applicant will maintain crowd control and public safety, and comply with Chapter 15. Noise of this Code.
- c. Alcohol event permit applications shall be examined by the appropriate departments of the city to ensure protection of the public health, safety and general welfare. In addition to normal concerns of each such department, particular attention will be given to traffic flow and control, auto and pedestrian safety, noise and the effect that the use and activity will have on surrounding uses, particularly where the adjoining use is residential.
- d. The alcohol event permit may be approved or denied by the city manager or designee based on compliance with this subsection. The city manager or designee may impose additional special conditions as deemed necessary to protect the public health, safety and general welfare.

1	e.	Only six (6) alcohol event permits may be issued per calendar year per applicant pe	
2		location. However, one alcohol event permit may include all of the University of	
3		Florida home football games for the school year.	
4	<u>fe</u> .	Each alcohol event permit issued shall be subject to the following conditions,	
5		requirements and limitations, as well as any other special conditions stated in the	

- requirements and limitations, as well as any other special conditions stated in the permit.
  - 1. A sufficient number of off-duty law enforcement officers and fire-rescue personnel, as determined by the city, shall be employed by the permittee to provide security, crowd control and emergency medical services for the event.
  - 2. The event may be open to the public only during the hours 10:00 a.m. to 2:00 a.m. the following day. Each event shall be limited to 48 consecutive hours, inclusive of time for set-up and clean-up.
  - 3. The sale, dispensing, consumption and possession of alcoholic beverages shall occur only within an area secured by fencing or barricades a minimum of four feet in height and with limited points of entry and exit. The permittee shall not allow alcoholic beverages purchased outside of the permitted area to be brought into or consumed inside the permitted area. Nor shall the permittee allow alcoholic beverages sold inside the permitted area to be taken out of, or consumed outside of the permitted area.
- (e) *Alcohol event permits, generally*. An application for an alcohol event permit may not be submitted more than six months prior to the first day of the event. If the city manager or designee determines that an event is creating a clear and present danger of a riot or other general public disorder, or substantial injury to persons or to property, the city manager or

1	designee may require the immediate cessation of the sale, dispensing, consumption and
2	possession of alcoholic beverages or may require the immediate cessation of the event. In
3	addition, if the city manager or designee finds that the requirements or conditions of an alcohol
4	event permit have been violated, and not cured within a reasonable time after reasonable notice
5	to the permit holder, the city manager or designee may require the immediate cessation of the
6	sale, dispensing, consumption and possession of alcoholic beverages or may require the
7	immediate cessation of the event.

- (f) Penalties. The provisions of this section regarding the unlawful open consumption of and/or possession of an open container of alcoholic beverage, may be enforced by civil citation as provided in sections 2-236 through 2-339 of the Code, or by criminal citation, as provided in section 1-9 of the Code. Any person not in compliance with any section of this article shall be subject to the penalties designated in sections 1-9 or 2-339 of this Code. Each violation shall be considered a separate offense, which can be prosecuted separately.
- Section 3. Section 18-20 in Article II of Chapter 18 of the Code of Ordinances of
  Gainesville, Florida is hereby amended as follows. Except as amended herein, the remainder of
  Section 18-20 remains in full force and effect.
