# APPLICIBLE RULE OF CONDUCT

Gainesville Police Department General Order 22.4 Overtime/Extra Duty Details

Failure to work overtime Rule 27

## COMPLAINT / NOTES / SUMMARY

# **COMPLAINT SUMMARY:**

On March 8, 2022, Sgt. J. Hutchinson was made aware of the absence of an SRO at Littlewood Elementary School. He searched the Overtime Module and discovered Ofc. C. Bivins had signed up to work. Sgt. Hutchinson attempted to contact Ofc. Bivins by phone, with no answer. Sgt. Hutchinson then attempted to contact Ofc. Bivins, in person, at his residence but did not receive an answer. According to Sgt. Hutchinson, Ofc. Bivins contacted him later in the day and stated he was just waking up and had forgotten he signed up for the assignment. Ofc. Bivins explained he had forgotten about the assignment because he signed up for it in the Overtime Module a few days before the detail. Sgt. Hutchinson noted that Ofc. Bivins was apologetic and upset that he had forgotten the assignment.

### **INVESTIGATION OF COMPLAINT:**

I reviewed the following documents to complete this investigation:

- Administration Referral Form (AIR)
- Overtime Module Roster Details

On March 8, 2022 at 0700hrs, Ofc. C. Bivins failed to work an overtime assignment he signed up for. I accessed the Overtime Module and discovered Ofc. Bivins was the only officer on the roster to work the assignment. I contacted the Special Details Coordinator, Hannah Smith, who advised that Ofc. Bivins signed up for the assignment on March 3, 2022 at 1359hrs, 5 days prior to the scheduled date.

### **CONCLUSION**

Ofc. Bivins failure to work the overtime assignment, or locate a replacement to work in his place, constitutes a violation of Gainesville Police Department G.O. 22.4 Overtime/ Extra-Duty Details and City of Gainesville E3 Rule 27 Failure to Work Overtime, therefore the allegation of Failure to Work Overtime is SUSTAINED.

This is Ofc. Bivins first violation of this rule. Officer Bivins will receive corrective action in the form of a Written Warning. Furthermore, Ofc. Bivins should be reminded that continued violations of this nature will result in progressive discipline, up to and including dismissal.
