RESOLUTION 120414

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA, RECOMMENDING APPROVAL OF REGISTERPATIENT.COM, INC. AS A QUALIFIED TARGET INDUSTRY BUSINESS; AGREEING TO BUDGET AND APPROPRIATE UP TO TWENTY FIVE THOUSAND SIX HUNDERED DOLLARS (\$25,600) AS LOCAL FINANCIAL SUPPORT IN THE QUALIFIED TARGET INDUSTRY TAX REFUND PROGRAM; PROVIDING AN IMMEDIATE EFFECTIVE DATE.

WHEREAS, the business under consideration, RegisterPatient.com, Inc., is a health technology and software company; and

WHEREAS, RegisterPatient.com, Inc., is currently located at 227 SW 4th Ave, Gainesville, FL and proposes an expansion in its operations to a new site within the City of Gainesville, Alachua County, Florida; and

WHEREAS, RegisterPatient.com, Inc., in its new site, will employ 32 employees and is anticipated to begin hiring in FY 2013/14 with an average annual compensation of \$45,000 per year and an estimated \$6,000 in benefits per worker; and

WHEREAS, RegisterPatient.com, Inc., will make a capital investment of \$513,800 over the next five years; and

WHEREAS, RegisterPatient.com, Inc., intends to locate its new site in an Enterprise Zone designated pursuant to s.290.0065, Florida Statutes, within the City of Gainesville, Alachua County, Florida at a location yet to be determined.

WHEREAS, RegisterPatient.com, Inc., intends to apply for the Qualified Target Industry Tax Refund for an Enterprise Zone location, pursuant to s.288.106(3), Florida Statutes; and

WHEREAS, the request by RegisterPatient.com, Inc., has been reviewed by Enterprise Florida's primary economic development partner in Gainesville/Alachua County, the Gainesville/Alachua County Council for Economic Outreach and Gainesville Area Chamber of Commerce; and

WHEREAS, on October 9, 2012, the Alachua County Board of County Commissioners approved funding 50% of the local financial support (\$25,600) towards this project; and,

WHEREAS, the Gainesville City Commission finds that the expenditure of City funds as local financial support for RegisterPatient.com, Inc., constitutes a valid public purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FL:

1. That the Commission finds, determines, and declares that the recitals in the preamble are true and correct, and hereby incorporates them by reference.
2. That in accordance with Section 288.106(4)(2)(10), Florida Statutes, the City Commission recommends that RegisterPatient.com, Inc., be approved as a Qualified Target Industry (QTI) Business.
3. That the City agrees to budget and appropriate up to \$25,600 as local financial support over a four year period commencing in FY 13 and running through FY 16 to the Florida Economic Development Trust Fund in the event that RegisterPatient.com, Inc. is certified as a QTI Business and locates its business within the City of Gainesville corporate limits and specifically within the City's established Enterprise Zone.
4. The City of Gainesville has determined the basis of this project's average private sector wage calculation shall be Alachua County's average private sector annual wage of \$34,446 as determined by Enterprise Florida.
5. This resolution shall take effect immediately upon its adoption.
