Mayor Pegeen - I've been up in D.C. lobbying for the FL Renewable RC&D Council with hopefully some success. Bill Nelson's offices are going to move forward together with Alan Boyd's people to assist our efforts in the coming months and years. The new Obama Administration may be looking our way for leadership.

I write to ask you to speak for us at the Agenda Review next Tues., November 25th. Because of the Council's own Nov. meeting no one can be at yours and the Agenda Review. We would ask that we be allowed to make a brief presentation at the Dec. 11th (?) CC meeting the purpose of which would be to 1) Present the Application, endorsed by the City, to USDA for Designation and quickly summarize the 4 major projects (by name and title only, as you would say), and 2) To seek support to nominate the Manager of Utilities, or perhaps a retiring Commissioner, to the Council's "Super" Board of Directors next year. RC&D Council Boards, embracing multiple counties as they do, usually have one or two County and City Commissioners, present or retired. In our case, we are asking Progress, Clay, GRU and Ocala Utilities to allow us to elect the CEO or others in leadership positions to this Super Board. John Masiello of Progress has already agreed to serve. I will be able
