| 20       | of the City Commission; and  |
| 21       | WHEREAS, the permanent protection of the City's most significant conservation,   |
| 22       | recreation, and cultural sites is in the best interests of the citizens of the City of Gainesville and   |
| 23       | future generations; and  |
| 24       | WHEREAS, the City Commission desires to propose for adoption an ordinance to   |
| 25       | amend the City Charter that would require referendum approval for the sale or conversion to  |
| 26       | another use of City-owned lands acquired or used for conservation, recreation, or cultural   |

| 28       | WHEREAS, the City Commission has considered this charter amendment, and by   |
| 29       | passage of this ordinance indicates its desire to approve the charter amendment as set forth   |

The registry shall be known as the "City of Gainesville Registry of Protected Public Places." At a public hearing the City Commission may add properties to the Registry by adopting an ordinance by a five-sevenths vote of the membership of the City Commission. The ordinance shall contain the legal description(s) of the site(s) and a description of the value(s) that support their inclusion on the Registry, and shall be recorded in the official public records. |
