An ordinance of the City of Gainesville, Florida, amending the Zoning Map Atlas and rezoning certain properties from the Alachua County zoning categories of "Highway oriented business services (BH) district" and "Administrative and professional (AP) district to the City of Gainesville zoning category of "BUS: General business district"; consisting of approximately 27.8 acres, and located in the vicinity of the 7200-7300 blocks of Northwest 4th Blvd.: providing directions to the City Manager; providing a severability clause: providing a repealing clause; and providing an immediate effective date.

WHEREAS, publication of notice of a public hearing was given that the Zoning Map Atlas be amended by rezoning certain properties from the Alachua County zoning categories of "Highway oriented business services (BH) district" and "Administrative and professional (AP) district" to the City of Gainesville zoning category of "BUS: General business district"; and WHEREAS, notice was given and publication made as required by law and a public hearing was held by the City Plan Board on April 28, 2011; and

WHEREAS, the City Commission finds that the rezoning of the property described herein will be consistent with the City of Gainesville Comprehensive Plan; and

WHEREAS, pursuant to law, an advertisement no less than two columns wide by 10 inches long was placed in a newspaper of general circulation and of the public hearing to be held in the City Commission Meeting Room, First Floor, City Hall, in the City of Gainesville at least seven (7) days after the day the first advertisement was published; and

16 17	Section 2. The City Manager is authorized and directed to make the necessary changes
18	in the Zoning Map to comply with this Ordinance.

20	or the application hereof to any person or circumstance is held invalid or unconstitutional, such
21	finding shall not affect the other provisions or applications of the ordinance which can be given
22	effect without the invalid or unconstitutional provisions or application, and to this end the
