My three dogs had two short stays with Bruce, and during those stays I watched my dogs on his doggie camera online while I was out of town. It was a great socialization event for my dogs, and I'm sure you know our community wants well socialized dogs. When I drove up to Bruce's house I heard no dogs barking outside, it was very quiet, although when I approached the door I did hear some barking. Bruce prefers to meet clients with their dogs outside to avoid triggering indoor barking. I spent time in his backyard with dogs mingling and it was quiet and the yard was neat and clean because he polices it regularly. He also behavior tested my dogs with the dogs who were already there to make sure that my dogs would be appropriate with the group. I was impressed with his dog behavior expertise because all the dogs in his care seemed relaxed and content.

Almost everyone has to work, and many people want companion animals even though they have to work, and they can't always afford to spend a lot of money for dog sitting. So many dogs are left home alone and some of them bark out of boredom or develop behavioral issues from stress and boredom. I think a dog sitting arrangement like Bruce has with his clients is an excellent solution for a working individual with a companion dog; the animal is less stressed, the owners are less stressed and Bruce loves the work. A secure and relaxed dog is much easier to train and more enjoyable to be with. Since having companion animals has become even more popular today than in the past, flexible options should be developed to promote successful dog-human relationships. A well cared for and trained dog is no more of a nuisance in a neighborhood than a well cared for and well behaved child, in my opinion, for those who are worried about the nuisance factors. On a more personal note, for eight years I fostered dogs one or two at a time, almost 70 total, working with abandoned animals who were going to be placed for adoption with a new person. I do think that

some of those dogs might not have been relinquished if the owner had a reliable, convenient, affordable dog sitter. I support Bruce's home business, and withink there should be more responsible dog sitting allowed in home settings because it is less stressful than a kennel or leaving the dog home alone.

Dear Mr. Hilliard,

I am Bruce Baber's next-door-neighbor and was incredibly dismayed to hear that again his right to legally care for dogs in his home is under attack. I have had signs in my yard, had bumper sticker on my car, sent countless emails to city officials, and attended city meetings to speak on his behalf for over a year now. I am far from the only neighbor who has done this. We have worked with the city tirelessly, to say nothing of Bruce's own efforts, to find a solution that will allow him to care for dogs in his home legally as he'd done before and am heartsick to hear that after coming so far he may not be able to. Of all the people who have made claims about the impact of his dogsitting business, I feel I am the most qualified to give a factual account of the impact his business has on this neighborhood. I live directly next to him and have for five and half years. Not one time di-I find his business in any way obtrusive. Not once have I been awoken by the sound of barking dogs or offended by the smell of dog waste. Not once have I had my ability to drive in my neighborhood impeded by the traffic of clients dropping off their dogs. Bruce always took considerable pains to limit any inconvenience to his neighbors and has always been approachable and willing to ameliorate any problems immediately. Because of his proximity, he is able to provide this service at an affordable rate. Clients don't have to driv very far, limiting the environmental impact of car travel. I'm a graduate student at UF and also work; I simply do not have the time to drive my dog across town to a brick-andmortar dogsitting service. The few times I have tried the financial strain made it impossibl to continue taking my dog there, and since my dog is a rescue from UF's animal research program, she has emotional scars from her past that make that environment very stressful for her. When I was able to take her to Bruce I felt comforted knowing she 1) wasn't going to damage my property due to boredom or separation anxiety; 2) was enriched physically and mentally by the home environment Bruce provides; and 3) loved dearly by a sweet, sensitive spirit who cares for and understands dogs (Bruce). Seeing the city's treatment of Bruce and the way they have reversed prior decisions in his favor makes me very disappointed in my local government. I understand that city officials need to take into

account the desires and needs of all Gainesville's citizens, but knowing how overwhelming the support for Bruce is in our neighborhood, the city is blatantly turning its back on the stated desires of our neighborhood if they refuse to find a way to allow Bruce's in-home dogsitting business.

I support Bruce Baber's dog-sitting and -walking service in its current location because the service could not otherwise exist economically or "locationally," if he were to have to move to a commercial location. It's not safe to walk a large number of dogs in the high-traffic areas associated with commercial enterprise. Nor could Bruce keep the costs of services low enough to benefit most of his clients, if he were to have to rent space in a commercial building. His location just north of the county's largest employer (UF) makes his operation convenient and efficient for the clients who can drop their dogs off and pick them up on the way to and from work, respectively.

The College Park neighborhood overwhelmingly supports Bruce's service, and his service operates much more quietly and with much less impact than the dominant residential rental activity which characterizes his surrounding neighbors. The rental properties in the neighborhood have more cars and more noise than Bruce's service generates. Further, Bruce keeps his property in better shape than most of the rental propert in the neighborhood. It's unfair to let landlords get away with running down the neighborhood, while focusing unnecessarily on a service that actually benefits the neighborhood in many ways.

Just think about that for a moment, and ask yourself what's actually fair in all this.

I am writing to urge you to enable Mr. Bruce Baber to resume his valuable service to the community via his dog-sitting service. Until City Commissioners made Mr. Baber close down his wonderful service, my husband and I had our dog stay with him every week while we were at work, as well as when we were out of town for business travel. This was a huge help for us. Our dog loved going to Bruce's home, and we were so glad that he could go to stay with Mr. Baber and play with his doggy buddies, rather than be kenneled when we were out of town. As President of the American Academy of Audiology, I am constantly on the road, sometimes even two trips in one week. It was such a relief to be able to drop Gordy off at Mr. Baber's house with not a single worry about his care. Additionally, Mr. Baber had several mini-cams so that patrons could check in on their dogs throughout the day, regardless if they were at work, at home, or traveling. I never sensed that Mr. Baber's neighbors were concerned about the dogs in any way. If Mr. Baber's neighbors felt that the dogs were a nuisance (e.g., running wild in the neighborhood, barking loudly outside, etc.), then that could be reported as a noise ordinance violation or it could be reported to the animal control department. However, to my knowledge, there have been no legitimate complaints from neighbors. One of my coworkers lives across the street from Mr. Baber and she is so sad that the dogs are no longer able to stay with Mr. Baber due to the decision of the City governance. I don't know if you have ever had the opportunity to observe a dog who is kenneled. I have never seen a kenneled dog who looked calm and happy to be sitting all day in a kennel cage. In contrast, when I would take a peek on the Mydogspace website minicams, I would see happy dogs playing with each other, or following Mr. Baber around the backyard as he did his chores, or sleeping blissfully on one of the sofas or chairs available for them. Since Gainesville is clearly a dog-lover's town, and Mr. Baber is appreciated so greatly by those of us who cannot always be available to walk our dogs during the day, and because the dogs are so happy to stay with Mr. Baber, I hope you will advise the City governance to let Mr. Baber continue his dog-sitting service in his home." "Last week I received an unexpected and grievous email from Bruce Baber that the City of Gainesville will no longer allow him to continue dog sitting. Bruce has provided a loving and caring environment for my Weimaraner Griffin for well over a year, which has allowed me to keep regular work hours in addition to starting a second business. Because of Bruce and Mydogspace, I was able to do this without having to worry about the health and happiness of my beloved family pet, Griffin, who requires special attention. Griffin suffers from severe separation anxiety and cannot be left alone for long periods of time. Through Bruce's love and care (and an exercise and medication regimen that Bruce also helps to supervise), Griffin has improved immensely and has finally begun to adapt to his environment. Taking him away from Bruce would undoubtedly disrupt this progress. Bruce's home is a safe shelter for many other dogs in addition to Griffin. He provides a wonderful and invaluable service to the pet owners. Many of his clients have expressed great concern for both Bruce and their pets should he be unable to continue his work. There is simply no one else in town that is able to do better what Bruce does. To deny him the ability to continue Mydogspace is a loss to all of us and it deprives Bruce of his employment and his livelihood." Brittany Lee

110640C "We've recently learned that our neighbor and dog sitter, Bruce Baber, will no longer be allowed to take care of our or anyone else's dogs at his home due to a codes violation. We are writing to urge you to work toward finding a way to allow Mr. Baber to continue providing dog sitting services out of his home. We adopted our puppy, Pooka, from the Humane Society in January of this year. Because she is too young to stay home alone for long, we have to find someone to watch her when we are gone from the house for more than a few hours. Mr. Baber offers not only a warm, friendly, healthy, and safe environment for our dog, but also a very affordable one. In most kennels, dogs are kept in crates or very small containment areas, and while able to see or hear each other, are kept separated; they are anxious, restless, and noisy. On the other hand, Bruce's dogs are not crated and have free access to part of his home, his yard, and the other dogs; for the most part, they're quiet and content. Have a look at the four webcam screens (now six) on Mr. Baber's website (www.brucebaber.com), and you'll see what we mean. Our dog loves going to Bruce's house for the day: when we bring her there, she can't get to the front door soon enough and runs inside without a backward glance at us. We are writing to support Mr. Baber not only as dog owners, but also as neighbors. Raising our three daughters in a neighborhood so close to the university, we've always been very supportive of any regulations that keep the neighborhood as "family friendly" as possible - from limits on the number of unrelated persons allowed to live in a home to limits on noise, business hours, etc. But neighborhoods need more businesses like Bruce's, not fewer. His services allow our family to enjoy the companionship of a dog while still dealing with the inevitable demands of work and school. "I am writing to you regarding Mr. Bruce Baber and the discontinuance of his in-home dog sitting service. Mr. Baber has been caring for my family's two Labrador retrievers over the past year during our out-of-town travels. The service that he provides is the best that you will find, and it is not about the money (and he is a bargain at \$10/day and \$12/if overnight). My two Labradors are part of my family and their well-being is of great concern to me and my children, as I am sure is the same with most pet owners. Under Bruce's care, we can be certain that our rambunctious labs have had 2-3 walks per day, have remained uncrated and had plenty of human contact, and have had the opportunity to run and play with various safe breeds of dogs all day. Mr. Baber also maintains a website that enables us to view our dogs on four web-cams to check-in throughout the day. How much better could the service be? One week ago, Mr. Baber was notified that he was in violation of Gainesville City Code regarding animals in residential areas. The code states that animals may not be kept in a home for purposes other than as a pet, unless allowed under a special use permit. Upon applying for the special use permit for operating a business in one's home, Mr. Baber was promptly notified that it was denied. Bruce maintains a controlled environment at his home, and he has developed a system to keep barking at a minimum. Bruce walks the dogs, several at a time, with bags in hand. My daughter's school bus passed Bruce on one of his walks recently and the children were thrilled. How could anyone not be? I urge the City Code Enforcement and the City Commissioners to please reconsider and issue Mr. Baber a special use permit to operate this business in his home. With its multiple dog parks, walking trails, specialized pet stores, and pet-accommodating hotels and restaurants, the City of Gainesville is a pet-friendly locale. Bruce Baber provides a much-needed, quality and affordable service to Gainesville's pet owners. He has dedicated his life now to caring for our pets, and this in-home pet service has become his only means of support. By not issuing him a special use permit to operate this business, the City of Gainesville is destroying Mr. Baber's livelihood and disappointing many of Gainesville's dog owners." Angela Hausman

My two dogs are a year old littermates that I had since they were 10 weeks old. I work long hours at the University of Florida and my partner works two days a week in Ocala, at the Marion county school system. On the days that she works, we used to take our dogs to Bruce. Bruce's business is a very convenient location for us, right on the way to work for both of us. The dogs loved going to Bruce's, they always ran to greet him with their tails wagging and then ran to the door to enter the house and see their doggie friends. Our dogs received good socialization at Bruce's and we loved knowing that they are safe. We were able to be worry-free during our workday, knowing that our girls

were safe, happy, and out of trouble. Then about 4 months ago, this ideal arrangement was disturbed. Bruce was informed that he would be unable to continue sitting dogs at his house due to an ordinance prohibiting keeping animals other than personal pets in his neighborhood. Our friend and former neid 1964 Gce Baber, who lives at 1713 NW 7th Avenue in Gainesville, has a dog-walking service that he operates out of his home. He's been walking neighborhood dogs for well over 20 years, and, after his mother died (he returned home after retiring from military employment to take care of her in her later years--she died at 94 in 2006), he started walking the dogs of people who worked at UF and who dropped their dogs off during the day on their way to work. He has taken every conceivable measure to buffer his yard from his neighbors, and only one has complained (the people who live in our old house at 1723 NW 7th Avenue). That neighbor complains that the dogs Bruce walks have caused flea infestations in their yard or house; but Bruce's house and yard are flea-free, so this contention simply doesn't hold water. Noise is not an issue either (or the other neighbors would have complained). Bruce always picks up after his dogs when he walks them, too (we know because we supply him with our used plastic bags, and he goes through them quickly!). Bruce's entire operation has been vetted through the Gainesville City Board of Adjustment just a month or so ago, and it was approved. No one objected to anything like what the 1723 NW 7th Avenue residents have submitted (the issue at the time was whether he was conducting an illegal business from his home). Since then, Bruce has continued to work on being a good neighbor by adding additional visual buffers, etc., to his property. Bruce is simply trying to provide a much-needed service doing the things he loves very much, dogs and exercise. He makes a little money on this service, just enough to enable him to continue living in the home he was born in. His parents built that house in 1940, and his family has continuously occupied that home since then (70 years!), while nearly everyone else has abandoned the neighborhood to absentee landlords who tend to trash their properties with no consideration for their neighbors. If you get a chance, drive by 1713 and 1723 NW 7th Avenue, and see which one keeps his or her house in a more "neighborly" condition! Then I think you will be able to judge that Bruce really is a good neighbor and deserves to keep providing his dog-walking service to his many happy customers, some of whom will surely be in attendance on February 3rd.
