An ordinance of the City of Gainesville, Florida, amending the Zoning Map Atlas and rezoning certain properties from undesignated rightof-way and the Alachua County zoning category of "Agricultural (A) district" to the City of Gainesville zoning category of "PS: Public services and operations district"; to allow pipelines, except natural gas; electric, gas and sanitary services, any use customarily incidental to any permitted principal use, utility lines, and water conservation areas, water reservoirs and control structures, drainage wells and water wells, as uses permitted by right; excepting the requirement of a preliminary development plan; consisting of approximately 35 acres, and located in the vicinity of the north side of North 53rd Avenue, extending from Northwest 3400 block to the Northeast 3000 block; providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

WHEREAS, publication of notice of a public hearing was given that the Zoning Map

- 22 Atlas be amended by rezoning certain properties from undesignated right-of-way and the Alachua
- County zoning category of "Agricultural (A) district" to the City of Gainesville zoning category 23
- of "PS: Public services and operations district"; and 24
- WHEREAS, notice was given and publication made as required by law and a public 25
- hearing was held by the City Plan Board on May 26, 2011; and 26
- WHEREAS, the City Commission finds that the rezoning of the property described 27
- 28 herein will be consistent with the City of Gainesville Comprehensive Plan; and
- 29 WHEREAS, pursuant to law, an advertisement no less than two columns wide by 10 inches
- long was placed in a newspaper of general circulation and of the public hearing to be held in the 30
- City Commission Meeting Room, First Floor, City Hall, in the City of Gainesville at least seven (7) 31
- days after the day the first advertisement was published; and 32

1	WHEREAS, a second advertisement no less than two columns wide by 10 inches long was
2	placed in the aforesaid newspaper notifying the public of the second public hearing to be held at the
3	adoption stage at least five (5) days after the day the second advertisement was published; and
4	WHEREAS, Public Hearings were held pursuant to the published and mailed notices
5	described above at which hearings the parties in interest and all others had an opportunity to be and
6	were, in fact, heard.
7	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE
8	CITY OF GAINESVILLE, FLORIDA:
9	Section 1. The Zoning Map Atlas of the City of Gainesville is amended by rezoning the
10	following described properties from undesignated right-of-way and the Alachua County zoning
11	category of "Agricultural (A) district" to the City of Gainesville zoning category of "PS: Public
12	services and operations district", as more specifically described below:
13 14 15	See legal description attached hereto as Exhibit "A" and made a part hereof as if set forth in full.
16	Section 2. The City Commission finds that a preliminary development plan
17	is not required in connection with this rezoning.
8	Section 3. The uses permitted by right on the property described in Section 1 of this
9	Ordinance are: pipelines, except natural gas (MG-46); electric, gas and sanitary services (MG-
20	49); any use customarily incidental to any permitted principal use; utility lines, and water
21	conservation areas, water reservoirs and control structures, drainage wells and water well; as
22	uses permitted by right.

Section 4. The City Manager is authorized and directed to make the necessary changes

1	in the Zoning Map to comply with this Ordinance.
2	Section 5. If any word, phrase, clause, paragraph, section or provision of this ordinance
3	or the application hereof to any person or circumstance is held invalid or unconstitutional, such
4	finding shall not affect the other provisions or applications of the ordinance which can be given
5	effect without the invalid or unconstitutional provisions or application, and to this end the
6	provisions of this ordinance are declared severable.
7	Section 6. All ordinances, or parts of ordinances, in conflict herewith are to the extent of
8	such conflict hereby repealed.
9	Section 7. This ordinance shall become effective immediately upon final adoption;
10	however, the rezoning shall not become effective until the amendment to the City of Gainesville
11	Comprehensive Plan adopted by Ordinance No. 110046 becomes effective as provided therein.
