Additional Information – Surtax Discussion


On June 5, the Alachua County Commission held a Special Meeting – General Policy Discussion. One of the items on the agenda was a Surtax Discussion. During that discussion, Commissioner Bradley proposed the following:

- 1) Reconsider the ¼ cent Transit Surtax if the BRT, articulated buses, and urban circulator projects are removed;
- 2) The remaining transit projects on the list are better defined;
- 3) The time period for the Transit Surtax is reduced to either 4 or 6 years;
- 4) If BRT is ready at end of the period go back to the voters to extend;
- 5) Reduce all road agreements to 10 years;
- 6) Remove requirement for county to require a supermajority on future amendments; and,
- 7) Allow 1 or 2% of the road funding to be spent on sidewalks.

The County Commission has an item on their June 12, 2012 agenda to consider authorizing the advertisement of the Ordinance establishing the ballot language for the roads initiative. They also intend to discuss Commissioner Bradley's proposal and any response the City Commission may offer as a result of your discussion at your June 7 meeting.

In regards to the request for a better defined transit exhibit Mr. Gomez had prepared the attached document in anticipation of the ballot initiative moving forward. The list identifies the projects that have been discussed and/or presented during previous meetings. The City Commission may consider forwarding this or some aspects of this document as an amended Exhibit "A".









