SECOND AMENDED FINAL JUDGMENT

The parties have stipulated that the legal issues in all 93 cases are identical and have agreed to present one representative case to the Court for consideration, Citation No. 17550. The parties have further stipulated that the factual issues are identical to the extent that one group of the cases involves Watson's Towing and the other group involves Elite/Ultimate Towing.

This Court took testimony from Lt. Pete Backhaus from the Gainesville Police Department and Stan Forron, owner of Ultimate/Elite Towing, reviewed the citations in all 93 cases, and received and reviewed written legal authority and argument from both parties.

The City of Gainesville issued 93 citations for alleged violations of Gainesville Code of Ordinances 14.5-33, effective date July 23, 2007. The parties stipulated that all 93 citations were written for alleged incidents occurring after the effective date of this Ordinance.

At issue in this case is the factual application of the 93 tows in question to the following section of Gainesville Code of Ordinances, Article III Section 14.5-33 referred to as "Point of Tow," which states:

Except as provided in Sec. 14.5-32 above and except for bona fide emergencies, a vehicle in tow shall be taken from the point of tow to the permanent business address of the tow owner or operator where vehicles are normally stored. Temporary storage is prohibited. (Emphasis added).

A copy of various minutes of the Gainesville City Commission Meetings was provided by

the defense for consideration by the court. At the March 29, 2007, Commission hearing regarding the towing ordinance in question, recommendation (6) states: "Towing directly to the permanent address of towing facility; towed vehicles must be taken directly from the point of tow to the permanent business address. Vehicles in-tow may not be temporarily held at any location other than the secured business address of the contracted wrecker service conducting the tow." (Emphasis added.)

The Court finds that the address provided by the tow company to the Gainesville Police Department and the address on file with the Florida Department of State Division of Corporations established the permanent business address for purposes of Gainesville Code of Ordinances 14.5-33.

In the representative case, Citation #17550, the Court received evidence that a vehicle was towed by Watson's Towing, driver #421, to 907 SW 3rd Street, Gainesville, Florida. The Court finds that Watson's permanent business address is 516 SW 1rd Street, Gainesville, Florida, and Ultimate/Elice Towing's permanent business address is 907 SW 3rd Street, Gainesville, Florida.

The Court also heard testimony and received documentary evidence that Ultimate/Elite and Watson Towing applied for a Zoning Compliance Permit (Occupational License) on August 8, 2007, essentially combining both lots as the permanent business location for both tow companies. This application was approved after the date of the 93 tows in question. The Florida Department of State Division of Corporations records also show that the date the business address was changed for Elite and Ultimate Towing to 516 SW 1st Street, Gamesville, Florida, was on 10/11/07 and 10/15/07, again after the date of the 93 tows in question.

There were two photos presented by the defendants, one each of Watson's and Elite's tow truck, both with lettering depicting the addresses of 516 SW 1st Street and 907 SW 3rd Street on each, and the Elite tow truck with the phone numbers 335-7799 and (352) 376-5829 and the Watson tow truck bearing the phone number 373-7475. There was also testimony that both lots had signage of all three businesses. The Court finds that the lettering on the tow truck and signage on the property, while required by Florida Statute 715.07, does not establish the legal permanent business address for purposes of the Gainesville City Ordinance.

ORDERED AND ADJUDGED that based upon the evidence presented at the trial, and consideration of the written legal authorities and arguments submitted by the parties after the hearing, the Court finds in favor of the Plaintiff.

IT IS FURTHER ORDERED AND ADJUDGED that pursuant to section 14.5-38(1) of the Gainesville City Ordinance that the defendants shall refund all towing costs and storage fees actually paid by the owners or lessees of the 93 vehicles towed. The refunds shall be paid within 30 days from the date of this Order.

IT IS FURTHER ORDERED AND ADJUDGED that pursuant to 14.5-38(2) of the Gaineswille City Ordinance the defendants pay a fine of \$25.00 per citation. In addition, pursuant to Section 34.045(1)(b), Florida Statutes, the defendants as the nonprevailing parties shall pay court costs of \$40 per citation to the Clerk of Court. The fines and court costs also shall be paid within 30 days from the date of this order.

Commission delays decision on towing rate increase

Gainesville tow-truck companies are frustrated, but not with angry drivers.

The Gainesville City Commission voted 4-3 Thursday to send a proposed price hike for roam towing rates back to the Public Safety Committee. The same committee recommended earlier this year that the commission pass the measure.

The measure would change the penalty for parking in an unauthorized spot from \$76 to \$84. The city sets towing fees for companies that tow illegally parked cars, and this measure would only affect rates for cars parked in unauthorized spaces.

Some towing companies were expecting a vote on the measure Thursday.

"I think it's bulls--t," said Stan Forron, owner of Ultimate Towing, which spearheaded the effort to increase penalties.

The commission decided to send the proposal back to the committee because the city doesn't have a structured system for increasing the towing rates.

"We are completely going over the entire tow ordinance and making updates and changes," City Commissioner Lauren Poe said. "My hope is that we are able to find a sound methodology for why the towing rates are wha they are."

Forron, who has been in the towing business for 26 years, said rising fuel costs threaten his businesses' future and said the legislative delay doesn't help his situation.

"We can't afford to upgrade equipment," he said. "I cut my drivers' pay. We don't buy new trucks. We cut out health insurance. We cut out all the driver benefits."

Forron warned that if the commission doesn't make a decision about raising the rate, he could be forced to crack down on illegal parking to make ends meet.

"What's going to happen is towing companies are going to get more predatory. We're going to tow more questionable cars," Forron said. "So park just a little bit on the grass or just a little bit over that white line, and we're towing that car now."

Subject: Tallahassee Trespass Towing Fees

Tallahassee City Ordinance, 20-168 (a) (1) which regulates trespass towing currently sets the rate for the trespass tow of a class A vehicle at \$88.00.

City Ordinance 20-168 (c) also describes the how trespass towing and storage fees are established and regulated. The ordinance states in part that "maximum trespass towing and storage fees shall be established annually by the City commission after receiving recommendations based on financial information submitted by he trespass towing companies as to their coasts for the removal and storage of vehicles and personal property and on other information. The required information shall be submitted by the towing company owners by October 31 of each year. Such maximum fees shall be effective during the following calendar year and until changed in subsequently resolution".
