The Contractor is hereby directed to make the following changes in the subject Contract:

1. NATURE OF CHANGES

1.1 Description of Changes

There was more asphalt above the gutter on NW 22nd Street and NW 5th Avenue than originally expected. This caused the original planned depth of milling to be insufficient to reach a depth below the lip of the gutter to provide area for the new asphalt to meet the lip of gutter. This change order includes the work to mill the additional depth required in order for the new asphalt to meet the lip of gutter. Also included in this change order is the cost to remove 5 trees that were not called out for removal in the plans but needed to be removed in order to construct the proposed sidewalk.

New pay item "NW22-A17 Additional Milling Mobilization" has been added at a lump sum price of \$4,950. New pay item "NW22-A18 Additional Milling Maintenance of Traffic" has been added at a lump sum price of \$3,000. New pay item "NW22-A19 Clearing & Grubbing – Unplanned Trees" has been added at a lump sum price of \$5,925. New pay item "NW22-A20 Additional Milling NW 5th Avenue" has been added at a lump sum price of \$9,976.65. New pay item "NW22-A21 Additional Milling – NW 22nd Street" has been added at a lump sum price of \$25,113.12. New pay item "NW22-A22 Additional Milling – Asphalt Prep" has been added at a lump sum price of \$8,316.60. The total of these added items is an additional \$57,281.37.
