18	owner whose land will be redesignated by enactment of this ordinance and whose address is
19	known by reference to the latest ad valorem tax records, notifying such property owners of this
20	proposed ordinance and of a public hearing in the City Hall Auditorium, First Floor, City Hall, in
21	the City of Gainesville; and
22	WHEREAS, at least ten (10) days notice has been given once by publication in a
23	newspaper of general circulation notifying the public of this proposed ordinance and of a public
24	hearing in the City Hall Auditorium, First Floor, City Hall, City of Gainesville; and

Section 1. The existing Figure 1.2 District Boundary Map - Urban Village and Figure 2.3

1	Primary Frontage Streets – Urban Village in Section 30-65.2 of the Land Development Code are
2	both deleted and replaced with the respective figures in Exhibit "A." For visual reference only,
3	the locations of both the approximately 2.8 acres of property being added to and the
4	approximately 497 square feet of property being removed from the Urban Village UMU-2 district
5	boundary are depicted on the maps attached as Exhibit "B." Except as amended herein, the
6	remainder of Section 30-65.2 remains in full force and effect.
7	Section 2. It is the intention of the City Commission that the provisions of Section 1 of
8	this ordinance shall become and be made a part of the Code of Ordinances of the City of
9	Gainesville, Florida.
10	Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance
11	or the application hereof to any person or circumstance is held invalid or unconstitutional, such

14	provisions of this ordinance are declared severable.
15	Section 4. All ordinances or parts of ordinances in conflict herewith are to the extent of
16	such conflict hereby repealed.
17	Section 5. This ordinance shall become effective immediately upon adoption.




Exhibit "A" to Ordinance No. 120426 (1 of 2)






Exhibit "A" to Ordinance No. 120426 (2 of 2)
