

**RESOLUTION NO. 13-009
EFFECTIVE JUNE 27, 2013**

**RESOLUTION ACCEPTING AN ANTICIPATED GRANT OFFER FROM
DEPARTMENT OF TRANSPORTATION, FEDERAL AVIATION
ADMINISTRATION AND AUTHORIZING EXECUTION BY THE
APPROPRIATE OFFICIALS ON BEHALF OF THE GAINESVILLE-ALACHUA
COUNTY REGIONAL AIRPORT AUTHORITY**

WHEREAS, on June 19, 2013, the Gainesville-Alachua County Regional Airport Authority received bids for the Rehabilitation of Taxiway E Pavement Full Length and Width (approx. 7,500' by 75'); Construction of T/W E Connector to Commercial Apron; and Rehabilitation of Taxiway E and R/W 11-29 Edge Lights and Markings; and Removal of Airfield Debris Pile (wildlife attractant); and

WHEREAS, following the approval of contract bids and submission of the Project Application to the Federal Aviation Administration the said FAA is anticipated to submit a Grant Agreement which constitutes an Offer to the City of Gainesville and the Gainesville-Alachua County Regional Airport Authority to be executed by the appropriate officials which, when so accepted, will constitute a Grant Agreement by which the United States Government will participate in the allowable costs of the project with the Federal Share to be up to an estimated \$4,643,358.00, representing ninety percent (90%) of anticipated project costs. The amount of the Grant Offer and the scope of work may be reduced by the FAA to match the available federal funding. The FAA share shall remain at 90% of the anticipated project costs and the FDOT share of the projects shall be \$166,685.00 of the anticipated project costs (grant received) and the balance to come from anticipated PFC collections; and

WHEREAS, for the purpose of receiving Federal Grant funds, the FAA requires that the City of Gainesville and the Gainesville-Alachua County Regional Airport Authority both promptly approve the Offer and the Gainesville-Alachua County Regional Airport Authority hereby requests that the City of Gainesville approve said Offer;

NOW, THEREFORE,

**BE IT RESOLVED BY THE GAINESVILLE-ALACHUA COUNTY
REGIONAL AIRPORT AUTHORITY**, as follows:

Section 1. That the Gainesville-Alachua County Regional Airport Authority, in anticipation of said Grant Offer, shall promptly enter into a Grant Agreement for the purpose of obtaining Federal aid under Project No. 3-12-0028-36-2013 that is to be implemented, constructed, and operated by the Gainesville-Alachua County Regional Airport Authority in accordance with Chapter 2006-363, Laws of Florida, and that such Grant Agreement shall be hereby made a part hereof.

Section 2. The Gainesville-Alachua County Regional Airport Authority, being familiar with expected terms of said Grant Offer, does hereby ratify and adopt all statements, representations, warranties, covenants, and agreements contained in said Offer, and by such acceptance agrees to abide by all of the terms and conditions of the Grant Agreement.

Section 3. That the Gainesville-Alachua County Regional Airport Authority hereby authorizes Allan J. Penksa, Chief Executive Officer, to prioritize and negotiate any needed reductions in the project scope of work with the FAA necessary to match the available federal funding or FAA determinations regarding grant eligibility, such reductions in scope to be consistent with the itemized project bids received on June 19, 2013 and included in the FAA grant application dated June 27, 2013; to amend said grant application if required by FAA in order to reflect any reduction in the scope of work; and to accept the Grant Agreement offer from the USDOT, subject to review by the Attorney for the Authority, and to fully execute and sign such documents as may be necessary.


