

RESOLUTION NO. 130220

PASSED September 5, 2013

A Resolution of the City of Gainesville, Florida, accepting FAA AIP Grant No. 3-12-0028-036-2013 from the U.S. Department of Transportation, Federal Aviation Administration, and authorizing execution by the Mayor and the Clerk of the Commission on behalf of the City of Gainesville; and providing an immediate effective date.

WHEREAS, on July 22, 2013, the Gainesville-Alachua County Regional Airport Authority (GACRAA) submitted a project application to the U.S. Department of Transportation, Federal Aviation Administration (FAA) seeking federal grant funds in an amount of up to \$4,661,619.00, representing 90% of the eligible project costs, for the following project at Gainesville Regional Airport: **Rehabilitation of Taxiway E Pavement Full Length and Width (approx.. 7,500' by 75')**; **Construction of T/W E Connector to Commercial Apron; Rehabilitation of Taxiway E and R/W 11-29 Edge Lights and Markings; and Removal of Airfield Debris Pile (wildlife attractant); and**

WHEREAS, the FAA is anticipated to submit, prior to the close of the 2013 federal fiscal year on September 30, 2013, a grant offer to the City of Gainesville and the GACRAA to be executed by the appropriate officials which, when so accepted, will constitute a grant agreement by which the United States Government will participate in the allowable costs of the project with the federal share to include an amount of up to \$4,661,619.00, or 90% of eligible project costs; and

WHEREAS, for the purpose of receiving federal grant funds, the FAA requires that the City of Gainesville and the GACRAA both accept the said grant offer no later than the close of the 2013 federal fiscal year on September 30, 2013; and

WHEREAS, on June 27, 2013, the GACRAA adopted Resolution No. 13-009, which accepted and authorized execution of the anticipated grant offer and authorized the Airport's Chief Executive Officer to prioritize and negotiate with the FAA any needed reductions in the project scope of work to match the available federal funding; and

WHEREAS, Gainesville Regional Airport staff has requested that the City of Gainesville approve the anticipated grant offer subject to final approval by the GACRAA and the City Attorney;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

Section 1. In anticipation of said grant offer from the FAA, the City of Gainesville shall accept and enter into Grant Agreement 3-12-0028-036-2013 for the purpose of obtaining federal aid in the development and operation of the Gainesville Regional Airport pursuant to Grant Agreement 3-12-0028-036-2013 and that is to be

implemented, constructed and operated by the GACRAA in accordance with Chapter 2006-363, Laws of Florida.

Section 2. The City of Gainesville, being familiar with the expected terms of said grant offer, does hereby ratify and adopt all statements, representations, warranties, covenants and agreements contained in and incorporated into FAA Grant Agreement 3-12-0028-036-2013, and by such acceptance, and in reliance upon the assurances of the GACRAA's Chief Executive Officer that the GACRAA agrees to abide by all of the terms and conditions of said Grant Agreement and the assurances made by GACRAA in Resolution No. 13-009, does agree to all of the terms and conditions thereof.

Section 3. The GACRAA represents to the City of Gainesville that GACRAA has adequate available funds to pay GACRAA's 10% share of the project's anticipated costs.

Section 4. Edward B. Braddy, Mayor, is hereby authorized and directed to execute said Grant Agreement 3-12-0028-036-2013 on behalf of the City of Gainesville in the amount of \$4,661,619.00 or at any lesser amount offered by the FAA with a corresponding reduction in the scope of work and related costs as itemized in the project application dated July 22, 2013, and Kurt M. Lannon, Clerk of the Commission, is hereby authorized and directed to impress the official seal of the City of Gainesville and to attest to said execution.

Section 4. This resolution shall take effect immediately upon adoption.
