City/County Interlocal Agreement for The Transition Of Services Upon An Annexation

- Made and entered into March 13, 2007
- Acknowledges the Alachua County Boundary Adjustment Act
- Recognizes the potential for jurisdictional impacts of major annexations and the need for intergovernmental cooperation
- Defines "Major" as a reduction of greater than 3% of the unincorporated area population or taxable property value
- Recognizes the need for the smooth and proper transition of services and capital projects between the City and County
- Acknowledges the City and County responsibility for the provision of fire services within their jurisdictional boundaries



Transition of Fire Services and Facilities

Ownership and Location or Transfer of Fire Rescue Stations and Employment of Fire Rescue Personnel:

- 1. In the event that a County fire rescue station is annexed by the City, the County may, at its discretion, continue to own and operate the station. The County may also elect to retain ownership, in whole or in part, of the station for emergency medical services or any other County purposes.
- Capital items assigned to the affected fire rescue station will remain County property.
- 3. If the City desires to own and/or operate the station, the City may negotiate an agreement with the County for the appropriate timing, terms, and conditions of the transfer and/or purchase of the station.



Employment of Affected County Employees

- Allows that if the City is hiring equivalent positions, the City shall offer to employ the affected County employees subject to their complying with pre-employment conditions as would be required of other applicants in such positions.
- For positions covered by a City bargaining unit, the City agrees to negotiate in good faith with those bargaining units.



Transition of Other Services

- Most County services have been transitioned to the City.
- Some services like law enforcement occur immediately.
- Some services are transitioned over short time periods while active services are completed, such as Building Permits, Code Enforcement, and Solid Waste.
- County has requested the transfer of Forest Park.



Fire Services Assistance Agreement (FSAA)

- Automatic aid agreement between City of Gainesville and Alachua County.
- Defines the level of service to be provided.
- Identifies response resources recognized for payment under the agreement.
- Identifies The Alachua County Fire Services
 Master Plan for current and future station
 locations to be recognized under the agreement.
- Identifies the formula for payment.

- 2. direct the City Manager to initiate a transition plan that would staff a City squad unit to provide services in that area; and
- 3. determine if the City Commission desires to discuss the transfer of services for Station 19 and potential City acquisition of Station 19 with the County Commission.
