10	WHEREAS, notice was given as required by law that the text of the Land Development	
11	Code of the City of Gainesville, Florida, be amended and a public hearing was then held by the	
12	City Plan Board on August 22, 2013; and	
13	WHEREAS, pursuant to law, an advertisement no less than two columns wide by 10	
14	inches long was placed in a newspaper of general circulation and provided the public with at	
15	least seven (7) days' advance notice of the first public hearing to be held in the City Hall	
16	Auditorium, located on the first floor of City Hall in the City of Gainesville; and	
17	WHEREAS, a second advertisement no less than two columns wide by 10 inches long	
18	was placed in the aforesaid newspaper and provided the public with at least five (5) days'	
19	advance notice of the second public hearing; and	
20	WHEREAS, public hearings were held pursuant to the published notices described above	
21	at which hearings the parties in interest and all others had an opportunity to be and were, in fact,	
22	heard.	
23	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE	
24	CITY OF GAINESVILLE, FLORIDA:	
25	Section 1. Subsection 30-62(c) of the Land Development Code is amended as follows.	
26	Except as amended herein, the remainder of Section 30-62 remains in full force and effect.	
27	Sec. 30-62. – Automotive-oriented business district (BA).
