THIS AGREEMENT made and entered into this day of October, 2013, by and between the GAINESVILLE COMMUNITY REDEVELOPMENT AGENCY, a public body corporate and politic existing under the laws of the State of Florida ("CRA"), whose mailing address is P.O. Box 490, Station 48, Gainesville, Florida, $32627-0490$, and RAGIN LAWN SERVICES, a Florida corporation ("CONTRACTOR") whose mailing address is 2811 NW 154 ${ }^{\text {th }}$ Street, Gainesville, FL 32669, Phone (352) 215-5002, EIN \# 26-4068841.

## WITNESSETH:

1) The CRA engages CONTRACTOR to render and perform the following work: Specialty Landscape Maintenance in accordance with Scope of Services (Attachment A) and Proposal from Contractor dated 10/16/2013 (Attachment C), Project \# CFED - 24 - MN - 2011.
2) The CONTRACTOR is hired as an independent CONTRACTOR from $\underline{11 / 1 / 2013}$ to $\underline{09 / 30 / 2014}$ to complete the work. The parties agree that time is of the essence for the completion of the work.
3) In the performance of this Agreement, the CONTRACTOR will be acting in the capacity of an independent contractor and not as an agency, employee, partner, joint venture, or associate of the CRA. The CONTRACTOR shall be solely responsible for the means, method, techniques, sequences, and procedures utilized by the CONTRACTOR in the full performance of this agreement. Contractor shall comply with all applicable federal, state and local laws, rules and regulations.
4) The CONTRACTOR shall be compensated a total sum not to exceed $\$ 43,983.12$ (forty-three thousand nine hundred eighty-three dollars and twelve cents) as defined in Attachment B for satisfactory completion of the work
5) The CRA shall pay to the CONTRACTOR for the faithful performance of this Contract the sums due upon verified invoices) within thirty (30) days of receipt. CONTRACTOR shall submit invoices) within ten (10) business days after the work has been completed.
6) The CONTRACTOR understands and agrees that as an independent contractor, the CONTRACTOR is not entitled to any benefits due CRA employees, and may be terminated by the CRA for cause at any time without prior notice and without cause upon ten (10) days' prior written notice. If terminated without cause, the CONTRACTOR shall be paid a pro-rata sum for work satisfactorily completed as of the date of termination.
7) CONTRACTOR agrees to indemnify and hold harmless the CRA, its officers, agents and employees from liabilities, damages, losses and costs, including but not limited to, reasonable attorney's fees, to the extent caused by the negligence, recklessness, or intentional wrongful misconduct of the CONTRACTOR and persons employed or utilized by the CONTRACTOR in the performance of the work.
8) The CONTRACTOR and the CRA agree that nothing in this contract shall be interpreted as a waiver of the CRA's sovereign immunity under 768.28 Florida Statutes.
