## Chief Jones/Lee Libby:

The Guide to Equitable Sharing for State and Local Law Enforcement Agencies (April 2009), Section VIII.A.1.m, allows agencies to use up to 15 percent of its shared funds received

within the last two fiscal years to support community-based programs that support job skills, housing and other community-based programs whose mission is supportive of and consistent with law enforcement efforts. Cash donations are strictly prohibited, but your agency may purchase tangible goods or services to support the program, so long as the expenditure is permissible in accordance with the Guide. For example, operating costs, such as lease payments or office equipment, along with materials and supplies would be permissible expenditures. Salaries of individuals working with the organization are not permitted.

Accordingly, the use of equitable sharing funds to purchase/build a facility for the Reichert House is a permissible use of shared funds.

Please ensure that the Gainesville Police Department does not exceed the 15 percent cap for all expenditures in support of community based programs in the corresponding year.

Our Chief asked me for an opinion as to whether the department can use federal forfeiture funds to build a new building for the Reichert House program to be used for gang and crime prevention services for the city's youth. Due to the complexity of the issue, I told him I would like to get an opinion from DOJ.

The Reichert House is a 503(c) charity which pprovides services designed to give youth opportunities to learn about themselves and to assist them in achieving a lifestyle that is free from substance abuse, violent crime, and incarceration. The program provides the youth support to build positive lives for themselves so they can move into contributing roles in society. (<a href="http://www.reicherthouse.org/index.html">http://www.reicherthouse.org/index.html</a>) While the building would be used for a proper purpose under the Guide to Equitable Sharing, it would be built on non-city owned property and be owned by the charity, not the city. I perceive this may be an insurmountable hurdle. I would greatly appreciate your opinion as to the matter.
