### RESOLUTION #08- 066R

A RESOLUTION OF THE OSCEOLA COUNTY BOARD OF COUNTY COMMISSIONERS AMENDING THE SCHEDULE OF MAXIMUM RATES TO BE CHARGED FOR TOWING OF VEHICLES IN OSCEOLA COUNTY AS SET FORTH IN RESOLUTION #99/00-086 AND RESOLUTION 03-019R; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on June 19, 2000, the Osceola County Board of County Commissioners adopted Ordinance #00-08, which regulates towing and storage of vehicles within Osceola County, Florida; and

WHEREAS, Ordinance #00-08, authorizes the Osceola County Board of County Commissioners to adopt a schedule of maximum fees to be charged for towing and storing vehicles in Osceola County by Resolution; and

WHEREAS, on June 19, 2000, the Osceola County Board of County Commissioners adopted Resolution #99/00-086, which established a schedule of maximum fees to be charged for the towing and storing of vehicles in Osceola County, and

WHEREAS, on February 17, 2003, portions of Resolution #99/00-086 were amended by Resolution #03-019R; and

WHEREAS, due to an increase in fuel costs, local towing companies have requested an increase in certain rates authorized, by Resolution #99/00-086 and Resolution #03-019R, for towing of a vehicle within Osceola County.

**NOW, THEREFORE**, be it resolved by the Board of County Commissioners of Osceola County, Florida that:

### SECTION 1. SCHEDULE OF RATES.

The maximum rates which can be charged for trespass towing and non-consensual towing services in Osceola County are hereby amended as follows:

A. CLASS A VEHICLES (GROSS VEHICLE WEIGHT THROUGH 10,000 POUNDS OR VEHICLE CARRYING A VESSEL 15 FEET OR LESS IN LENGTH)

TRESPASS TOW (FLAT RATE) \$125.00
 NON-CONSENSUAL TOW \$125.00

B. CLASS B VEHICLES (GROSS VEHICLE WEIGHT 10,001 POUNDS OR MORE BUT LESS THAN 19,500 POUNDS OR VEHICLE CARRYING A VESSEL MORE THAN 15 FEET BUT LESS THAN 22 FEET IN LENGTH)

TRESPASS TOW (FLAT RATE) \$250.00
 NON-CONSENSUAL TOW \$250.00

C. CLASS C VEHICLES (GROSS VEHICLE WRIGHT 19,500 OR MORE POUNDS BUT LESS THAN 25,000 POUNDS OR VEHICLE CARRYING A VESSEL MORE THAN 22 FEET IN LENGTH)

TRESPASS TOW (FLAT RATE) \$375.00
 NON-CONSENSUAL TOW \$375.00

D. CLASS D VEHICLES (GROSS VEHICLE WEIGHT MORE THAN 25,000 POUNDS)

TRESPASS TOW (FLAT RATE) \$500.00
 NON-CONSENSUAL TOW \$500.00

### SECTION 2. SEVERABILITY.

It is declared to be the intent of the Board of County Commissioners that, if any section, subsection, sentence, clause, phrase, or portion of this Resolution, is for any reason held invalid or unconstitutional, by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

### SECTION 3. CONFLICT.

Any other Resolution or part thereof in conflict with this Resolution or any part hereof is hereby repealed to the extent of the conflict. This Resolution is in no way specifically intended

to invalidate any of the provisions of Resolution 99/00-086 or Resolution 03-019R which are not inconsistent with the provisions hereof.

### SECTION 4. EFFECTIVE DATE.

This Resolution shall be in force and take effect immediately upon its passage and adoption.
