9 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF**
10 **THE CITY OF GAINESVILLE, FLORIDA:**

11 **Section 1.** Objective 1.1 of the Future Land Use Element of the City of Gainesville
12 Comprehensive Plan is amended as stated below. Except as amended herein, the remainder
13 of Objective 1.1 and its Policies remain in full force and effect.

14 **Objective 1.1** **Adopt city urban design principles that adhere to timeless (proven**
15 **successful), traditional principles.**
16

17 **Section 2.** Objective 2.3 and its Policies are added to the Future Land Use
18 Element of the City of Gainesville Comprehensive Plan as stated below.

19 **Objective 2.3** **The City shall collaborate with the Community Redevelopment**
20 **Agency (CRA) to designate Community Redevelopment Areas that**
21 **encourage reinvestment in the form of capital projects, infill**
22 **redevelopment, and economic development programs designed to**
23 **eradicate slum and blight and enhance urban form.**
24

25 **Policy 2.3.1** **The City shall assist with the implementation, as appropriate, of the**
26 **Community Redevelopment Plan for the Downtown Community**
27 **Redevelopment Area.**

Policy 2.3.2 The City shall assist with the implementation, as appropriate, of the Community Redevelopment Plan for the Eastside Community Redevelopment Area.

Policy 2.3.3 The City shall assist with the implementation, as appropriate, of the Community Redevelopment Plan for the Fifth Avenue/Pleasant Street Community Redevelopment Area.

Policy 2.3.4 The City shall assist with the implementation, as appropriate, of the Community Redevelopment Plan for the College Park/University Heights Community Redevelopment Area.

Section 3. Policy 3.4.1 of the Future Land Use Element of the City of Gainesville

Comprehensive Plan is amended as stated below. Except as amended herein, the remainder of Objective 3.4 and its Policies remain in full force and effect.

Policy 3.4.1 The City shall determine and monitor whether facilities and services that will serve proposed development meet adopted LOS standards. The Concurrency Management System shall be used to maintain adopted LOS standards. Transportation Mobility LOS is excluded from the Concurrency Management System.

Section 4. Policies 3.5.5 and 3.5.6 are added the Future Land Use Element of the

City of Gainesville Comprehensive Plan as stated below. Except as amended herein, the remainder of Objective 3.5 and its Policies remain in full force and effect.

Policy 3.5.5 The City shall coordinate with the University of Florida regarding the implementation of the University of Florida Campus Master Plan, as appropriate, to support future university growth while mitigating any impacts on public facilities and services such as roads, utilities, parks and recreation.

Policy 3.5.6 The City and the University of Florida shall monitor development both on and off campus and assess impacts on University and City resources, facilities and services. When it has been determined that proposed development within the designated context area would have an adverse impact on University and/or City facilities and resources, the City will

1 participate and cooperate with University officials in the identification of
2 appropriate strategies to mitigate the impacts.
3

4 **Section 5.** The paragraph titled Commercial within Policy 4.1.1 of the Future Land
5 Use Element of the City of Gainesville Comprehensive Plan is amended as stated below.
6 Except as amended herein, the remainder of Objective 4.1 and its Policies remain in full
7 force and effect.

8 **Commercial**
9

10 The Commercial land use category identifies those areas most appropriate for large scale
11 highway-oriented commercial uses, ~~and, when designed sensitively, residential uses.~~ Land
12 development regulations shall determine the appropriate scale of uses. This category is not
13 appropriate for neighborhood centers. Intensity will be controlled by adopting height limits of
14 5 stories or less, requiring buildings to face the street, and modest build-to lines instead of a
15 maximum floor area ratio; however, height may be increased to a maximum of 8 stories by
16 special use permit.
17

18 **Section 6.** Subparagraphs c, i, j and m of Policy 4.3.5 of the Future Land Use
19 Element of the City of Gainesville Comprehensive Plan are amended as stated below.
20 Except as amended herein, the remainder of Objective 4.3 and its Policies remain in full
21 force and effect.

22 Policy 4.3.5 Due to the unique infrastructure and environmental constraints of the
23 Hatchet Creek Planned Use District (the "PUD"), as depicted on the map
24 labeled Hatchet Creek PUD Area in the Future Land Use Map Series A,
25 the PUD shall be governed by the following conditions:
26

- 27 c. The actual amount and types of residential units, ALF beds, and
28 non-residential development area will be specified in the PD
29 zoning ordinance as limited by the city, county and state
30 development restrictions and constraints, including but not limited
31 to, wetlands and surface water regulations, regulated natural and
32 archeological resources regulations, wellfield protection,
33 floodplain requirements, concurrency and airport hazard zoning
34 regulations.

- 2 i. Protection of the State-listed animal species Gopher tortoise
- 3 (Gopherus polyphemus) ~~listed as a Species of Special Concern in~~
- 4 ~~Rule 68A-27.005, F.A.C.,~~ located in the remnant sandhills east of
- 5 the Ironwood Golf Course, and documented in the applicant's
- 6 Hatchet Creek Planned Use District Report dated March 2007, is
- 7 required and shall be established in the PD zoning ordinance.

- 26 PUD shall be specified in the PD zoning ordinance and shall be in

- 30 application for PD zoning.

32 **Section 7.** Policies 4.7.2 and 4.7.5 of the Future Land Use Element of the City of

33 Gainesville Comprehensive Plan are amended as stated below. Except as amended herein,

34 the remainder of Objective 4.7 and its Policies remain in full force and effect.

36 Policy 4.7.2 To preserve and conserve significant ~~uplands~~ natural resource areas, the

37 following, policies (a) through (e) below shall apply. ~~Significant uplands~~

38 ~~are defined as forested upland communities (associations) of plants and~~

39 ~~animals, which, because of their great variety of species are deemed to be~~

1 of exceptional quality and richness (community completeness). These
2 habitats are typically of sufficient size to maintain normal flora and fauna;
3 have actual or potential linkages to other significant natural areas and
4 contain sufficient diversity among species and communities.
5

6 a. Preservation of upland significant natural communities, listed
7 species habitat, geological features, and areas of strategic
8 ecosystems shall be encouraged through public or private
9 acquisition where possible, and other appropriate methods of

27 ~~listed as either threatened or endangered.~~
28

29 a. The policies within the Conservation, Open Space and
30 Groundwater Recharge Element of the Gainesville Comprehensive
31 Plan shall apply as they relate to ~~threatened and endangered~~ listed
32 species.

34 b. ~~Threatened and endangered species listed in official Federal, State,~~
35 ~~or international treaty lists, i.e., “listed” species, “Listed species,”~~

6 of Goal 5 and its Policies remain in full force and effect.

24 **Objective 5.1** Urban design standards established in the Land Development Code
25 shall enhance the sense of place, improve the urban form, and provide
26 for the safety and comfort of pedestrians, bicycles, transit, and other
27 vehicles in the City. These standards shall reflect a commitment to
28 improve and maintain the vitality of the City and its neighborhoods.

29
30 ~~**Policy 5.1.1** The City shall create heritage, conservation or other appropriate overlay
31 districts as needed for neighborhood stabilization.~~

32
33 **Policy 5.1.1** Urban design standards established in the Land Development Code shall
34 foster predictable built results and a high-quality public realm with clear
35 distinctions between urban, suburban, and natural areas.

36
37 **Policy 5.1.2** Urban design standards established in the Land Development Code shall
38 address the relationship between building facades and the public realm,
39 the form and mass of buildings in relation to one another, and the scale
40 and types of streets and blocks.

2 **Objective 5.2 Guide large, corporate, national chain sales and service**
3 **establishments toward a design that promotes the unique character**
4 **and identity of Gainesville.**

5
6 **Policy 5.2.1** The City shall develop land development regulations that control facade
7 articulation, building orientation, building location, automobile-oriented
8 uses such as drive-throughs and gas stations, location and amount of
9 parking, number of stories, outdoor lighting, compatibility with context,
10 and quality of materials for large retail and service establishments in a
11 manner that promotes civic pride, unique identity and land use objectives.

12
13 **Objective 5.3 The City shall coordinate with the University of Florida design efforts**
14 **as contained within the Campus Master Plan and future design plans**
15 **for Innovation Square.**

16
17 **Policy 5.3.1** The City shall collaborate with the University to strengthen the image of
18 the City and the University through better design along University Avenue
19 and West 13th Street.

20
21 **Policy 5.3.2** The City and the University shall collaborate to enhance the portions of
22 SW 34th Street and Archer Road adjacent to the campus in order to
23 promote more multi-modal, quality urbanism.

24
25 **Policy 5.3.3** The City shall collaborate with the University to improve the design and
26 function of the Gateway Roads identified in the Campus Master Plan (SW
27 16th Avenue, Archer Road, SW 13th Street, University Avenue, SW 2nd
28 Avenue, and SW 34th Street) through University participation on the
29 Metropolitan Transportation Planning Organization and its committees,
30 the College Park/University Heights CRA Advisory Board, and any
31 boards or committees as may be created to address such issues.

32
33 **Objective 5.4 The City shall partner with neighborhoods to facilitate effective**
34 **communication between the neighborhood residents and the City and**
35 **develop specific actions to address neighborhood identified goals and**
36 **improvements.**

37
38 **Policy 5.4.1** The City shall create heritage, conservation or other appropriate overlay
39 districts as needed for neighborhood stabilization.

40
41 **Section 9.** The Urban Design Element of the City of Gainesville Comprehensive

42 Plan is deleted in its entirety.

~~GOAL 1 — PROTECT AND PROMOTE QUALITY OF LIFE AND LIVABILITY FOR THE CITIZENS OF GAINESVILLE THROUGH QUALITY URBAN DESIGN.~~

~~Objective 1.1 By 2003, the City shall adopt urban design standards in select locations in the city. Any adopted urban design standards shall reflect the particular character of that portion of the city, and shall reflect that the city includes transitions in character from urban to suburban. In general, the most comprehensive set of urban design standards should be applied to those areas which were built before World War II, which contain design elements that were common before World War II, or which are designed primarily for pedestrian activity, in addition to bicycle, transit and car travel. The City should also seek to establish these traditional, pedestrian-oriented quality of life design features in other areas when the need is identified. The City shall review its existing urban design standards for the Traditional City and Central Corridors as to appropriate boundaries, and establish urban design standards for other particular areas of the city as appropriate.~~

Policies

~~1.1.1 Indicators of traditional, pedestrian-oriented, urban areas appropriate for urban design standards should include some or all of the following characteristics:~~

- ~~• Building facades pulled up close to the street, facing the street, and generally aligned.~~
- ~~• Relatively high density mixed use, compactly laid out to accommodate walking.~~
- ~~• A mixture of housing types or prices.~~
- ~~• Multi-story buildings.~~
- ~~• Connected, narrow streets, or streets with modest turning radii.~~
- ~~• A connected network of sidewalks.~~
- ~~• Mature street trees lined up along the street.~~
- ~~• On-street parking.~~
- ~~• Off-street parking at sides or rear of buildings.~~
- ~~• Narrow, smaller lots.~~
- ~~• Front porches.~~
- ~~• Garages subservient to primary building.~~
- ~~• Short block faces.~~
- ~~• Terminated vistas.~~

- 1 1.1.2 ~~The City shall establish urban design standards which protect and promote quality of~~
 2 ~~life, in order to encourage redevelopment and new development within city limits~~
 3 ~~rather than in outlying areas by amending the City Land Development Code to adopt~~
 4 ~~additional urban design standards for any particular parts of the city.~~

- 6 1.1.3 ~~By 2002, based on the indicators in Policy 1.1.1, the **Traditional City boundaries**~~
 7 ~~shall be analyzed to determine whether the existing boundaries are appropriate, and~~

3 ~~1.1.8 The City shall encourage the conversion of activity centers and **conventional**~~
4 ~~**shopping centers** into more traditional, livable town centers through redevelopment~~
5 ~~or addition of uses, features and structures specified in Policy 1.1.7. Design of such~~
6 ~~redevelopment shall be supportive of transit. The City should encourage new,~~
7 ~~additional buildings relatively near the street where site planning allows adequate~~
8 ~~space, addition of residential units in existing activity centers, and design features~~
9 ~~that encourage a transformation of shopping centers into appealing, “destination”~~
10 ~~town centers. The City shall encourage the **conversion of surface parking lots** to~~
11 ~~buildings in activity centers being transformed into town centers. Minimum car~~
12 ~~parking requirements in activity centers shall be reduced as one incentive for the~~
13 ~~creation of mixed-use activity centers (allowing that former parking area to be used~~
14 ~~for “liner” buildings).~~

16 ~~1.1.9 The City shall strive to achieve a land use and transportation vision described in~~
17 ~~“Concept A” in the Urban Design Data and Analysis. This future growth concept~~
18 ~~features compact development, mixed use, infill, and higher densities in appropriate~~
19 ~~locations. Conventional shopping centers are transformed into walkable town~~
20 ~~centers, and the city is rich in transportation choices. Civic pride is high because of~~
21 ~~the high quality of urbanism. Residences and commercial development is~~
22 ~~increasingly attracted to in-town locations because urban qualities, such as~~
23 ~~walkability, vital and livable streets, safe and human-sealed neighborhoods,~~
24 ~~sociability, and unique character provide a quality urban experience unavailable~~

33 ~~1.2.1 By 2002, the City shall inventory and prioritize areas in need of **street trees,**~~
34 ~~**streetside sidewalks** (either the filling of gaps or enhancement of the material),~~
35 ~~modest **street light structures,** the **removal of utility structures** and other~~
36 ~~obstructions from sidewalks, and the undergrounding of utilities. By 2003, the~~
37 ~~City shall identify funding for such needed public improvements.~~

38
39 ~~1.2.2 By 2002, the City shall establish requirements and incentives in the City Land~~
40 ~~Development Code for new development to install **street trees and sidewalks** in~~
41 ~~instances in which they are not required as of the date of adoption of this~~

44 ~~1.2.3 The Land Development Code should require **street trees** that will provide~~

1 appropriate canopy and shading benefits, and that will be aligned in a disciplined
2 manner along streets in order to properly frame the street.

4 ~~1.2.4~~ The City shall encourage **on-street parking** in new developments, and shall re-
5 introduce it in existing areas that would benefit from it—particularly in the
6 Traditional City area.

7
8 ~~1.2.5~~ **Sidewalks** shall have a minimum clear width of five feet wide—wider in areas
9 with large pedestrian volumes.

10
11 ~~1.2.6~~ The City shall prohibit the installation of permanent structures—such as **utility**
12 **and traffic signal poles**—within sidewalks, unless a clear width of at least 5 feet
13 is maintained. The City shall require dedication of the necessary right-of-way or
14 provision of an easement to keep such structures out of the sidewalk when clear
15 width is otherwise inadequate.

18 is appropriate, and develop a plan for installing such lighting by an identified
19 date. Where appropriate, **street lighting** should be pedestrian-scaled (in both
20 intensity and height), and directed to the street.

22 ~~1.2.8~~ The City shall reduce minimum **off-street parking space requirements**, as
23 appropriate.

25 ~~1.2.9~~ The City shall encourage or require primary **building entrances** to be physically
26 and visually oriented toward streets, parks, and plazas, rather than to interior
27 squares or parking areas.

28
29 ~~1.2.10~~ When allowed by the underlying zoning district, some or all of at least the first
30 floor of multi-level **parking garages** shall be a wrap of residential, retail or
31 office space.

32
33 ~~1.2.11~~ **Terminating certain streets with a prominent vista**—such as a government
34 building, park, or clock tower—should be encouraged when a prominent civic
35 building is to be constructed.

36
37 ~~1.2.12~~ **CPTED** (Crime Prevention Through Environmental Design) principles shall be
38 incorporated, where feasible and appropriate, in new projects.

39
40 **Objective 1.3 Any additions or changes to the existing city street network pattern**
41 **shall be designed to provide interconnected patterns that promote**
42 **effective circulation of car, transit, bicycle, and foot traffic, and to take**
43 **some of the pressure off the major arterial streets in the city as the city**
44 **grows.**

4 ~~1.3.1~~ **Gridded, interconnected street networks** with a generally north-south, east-
5 west orientation are encouraged. Streets should be connected with other streets to
6 the maximum extent feasible.

7
8 ~~1.3.2~~ **Blocks** are encouraged to be generally rectangular in shape. Block length and
9 perimeter are encouraged to be modest.

10
11 ~~1.3.3~~ **Alleys** for rear access, when feasible and appropriate, are encouraged.

12
13 ~~1.3.4~~ The design of the street network shall make **walking** within the neighborhood
14 and to neighborhood edges **convenient and pleasant**.

15
16 ~~Objective 1.4~~ **The City should ensure that the location of off-street surface parking lots**
17 **reflects quality urban design.**

21 ~~1.4.1~~ In areas where the City seeks to promote transportation choices, all non-residential
22 off-street parking shall be **placed to the rear or side** of the building, rather than in
23 the front or otherwise adjacent to a street.

24
25 ~~1.4.2~~ In locations where the City continues to allow parking in front, **off-street parking**
26 **adjacent to a street** should be visually screened with a wall, fence, hedge, or berm.

27
28 ~~Objective 1.5~~ **Walls, fences and berms, where provided, shall be designed for aesthetics,**
29 **security, durability, and access.**

30
31 **Policies**

32
33 ~~1.5.1~~ New non-residential and mixed use **access points** (breaks or openings in walls,
34 fences or berms) shall be required along the side and/or rear of the property, rather
35 than just along the major access street.

10 **Section 10.** It is the intent of the City Commission that the provisions of Sections 1
11 through 9 shall become and be made a part of the City of Gainesville Comprehensive Plan
12 and that the sections and paragraphs of this ordinance may be renumbered in order to
13 accomplish such intentions.

14 **Section 11.** The City Manager or designee is authorized and directed to make the
15 necessary changes in the text, maps and other data in the City of Gainesville Comprehensive
16 Plan in order to fully implement this ordinance.

17 **Section 12.** Within ten (10) working days of the transmittal (first) hearing, the City
18 Manager or designee is authorized and directed to transmit this plan amendment and
19 appropriate supporting data and analyses to the reviewing agencies and to any other local
20 government or governmental agency that has filed a written request for same with the City.
21 Within ten (10) working days of the adoption (second) hearing, the City Manager or
22 designee is authorized and directed to transmit this plan amendment and appropriate
23 supporting data and analyses to the state land planning agency and any other agency or local
24 government that provided timely comments to the City.

25 **Section 13.** If any word, phrase, clause, paragraph, section or provision of this
26 ordinance or the application hereof to any person or circumstance is held invalid or
27 unconstitutional, such finding shall not affect the other provisions or applications of this

1 ordinance that can be given effect without the invalid or unconstitutional provision or
2 application, and to this end the provisions of this ordinance are declared severable.

3 **Section 14.** All ordinances or parts of ordinances in conflict herewith are to the
4 extent of such conflict hereby repealed on the effective date of this plan amendment.

5 **Section 15.** This ordinance shall become effective immediately upon adoption;
6 however, the effective date of this amendment to the City of Gainesville Comprehensive
7 Plan, if the amendment is not timely challenged, shall be 31 days after the state land planning
8 agency notifies the City that the plan amendment package is complete in accordance with
9 Section 163.3184, F.S. If timely challenged, this amendment shall become effective on the
10 date the state land planning agency or the Administration Commission enters a final order
11 determining this adopted amendment to be in compliance with Chapter 163, F.S. No
12 development orders, development permits, or land uses dependent on this amendment may be
13 issued or commenced before this plan amendment has become effective.
