An ordinance of the City of Gainesville, Florida, amending the Land Development Code to prohibit the operation of simulated gambling establishments, as defined in this ordinance, throughout Gainesville by excluding such use from the list of permitted uses in all zoning districts that otherwise allow amusement and recreation services; by adding new definitions to Section 30-23 Definitions; by amending the list of permitted uses in Sections 30-61. General business district (BUS), 30-62. Automotiveoriented business district (BA), 30-63. Tourist-oriented business district (BT), 30-64. Mixed use low intensity district (MU-1), 30-65. Mixed use medium intensity district (MU-2), 30-65.1. Urban mixed-use district 1 (UMU-1), 30-65.2. Urban mixed-use district 2 (UMU-2), 30-66. Central city district (CCD), 30-67.1. Business industrial district (BI), 30-68. Warehousing and wholesaling district (W), 30-69. Limited industrial district (I-1), 30-70. General industrial district (I-2), 30-75. Public services and operations district (PS); providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

WHEREAS, the State of Florida in April 2013 enacted Chapter 2013-2, Laws of Florida, clarifying the existing laws concerning slot machines, charitable drawings, game promotions and amusement machines to ensure that operation of such are not subject to abuse or interpreted in any manner as an exception to Florida's general prohibition against gambling or gaming; and WHEREAS, Section 1 of Chapter 2013-2, Laws of Florida, sets forth that there is a compelling state interest in prohibiting unlawful gambling or gaming in the State of Florida; and

WHEREAS, over the past several years, Florida has witnessed a proliferation of electronic sweepstakes or simulated gambling establishments commonly referred to as "internet cafés" ("simulated gambling establishments"); and

WHEREAS, the operation of simulated gambling establishments is contrary to the policy and laws enacted by the State of Florida in that such establishments are inherently deceptive and allow users to take part in activities as if they were engaging in gambling activities prohibited by Florida law; and

WHEREAS, it has been documented that gambling can lead to harmful behavior and is

1	often an addictive activity that has an unreasonable adverse effect upon persons that are
2	statistically at risk for gambling addictions and other similar compulsive behaviors; and
3	WHEREAS, it has also been documented that there is a direct relationship between
4	simulated gambling establishments and disturbances of the peace and good order of the
5	community; and
6	WHEREAS, prosecuting operators of simulated gambling establishments pursuant to
7	state law regarding slot machines, charitable drawings, game promotions, amusement machines,
8	and Florida's general prohibition against gambling or gaming can be difficult and costly; and
9	WHEREAS, the City Commission, after holding public hearings, finds that specifically
10	excluding simulated gambling establishments from the list of permitted uses in all applicable
11	zoning districts in the City of Gainesville is necessary to preserve the public peace and to
12	safeguard the health, safety, morals and welfare of the community and citizens thereof; and
13	WHEREAS, notice was given as required by law that the text of the Land Development
14	Code of the City of Gainesville, Florida, be amended to exclude simulated gambling
15	establishments, as defined in this ordinance, from the list of permitted uses in any zoning district
16	that allows amusement and recreation services; and
17	WHEREAS, on June 26, 2014, a public hearing was held by the City Plan Board, which
18	acts as the local planning agency pursuant to Section 163.3174, Florida Statutes, and makes
19	recommendations to the City Commission of the City of Gainesville; and
20	WHEREAS, an advertisement no less than two columns wide by 10 inches long was
21	placed in a newspaper of general circulation and provided the public with at least seven (7) days'
22	advance notice of this ordinance's first public hearing to be held by the City Commission in the
23	City Hall Auditorium, located on the first floor of City Hall in the City of Gainesville; and

1	WHEREAS, a second advertisement no less than two columns wide by 10 inches long
2	was placed in the aforesaid newspaper and provided the public with at least five (5) days
3	advance notice of this ordinance's second public hearing to be held by the City Commission in
4	the City Hall Auditorium, located on the first floor of City Hall in the City of Gainesville; and
5	WHEREAS, public hearings were held pursuant to the notices described above at which
6	hearings the parties in interest and all others had an opportunity to be and were, in fact, heard.
7	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE
