INTERLOCAL AGREEMENT BETWEEN ALACHUA COUNTY AND THE CITY OF <u>GAINESVILLE</u> FOR USE AND DISTRIBUTION OF 1 PERCENT (1%) OF THE FUNDS GENERATED BY A,CHARTER COUNTY AND REGIONAL TRANSPORTATION SYSTEM SALES SURTAX TO BE USED FOR IMPROVEMENT AND MAINTENANCE OF THE TRANSPORTATION SYSTEM

THIS INTERLOCAL AGREEMENT, entered into this day of,
2014, between Alachua County, a charter county and a political subdivision of the State of
Florida, by and through its Board of County Commissioners (hereinafter referred to as the
"County"), and the City of <u>Gainesville</u> , by and through its City Commissioners, a municipal
corporation of the State of Florida, (hereinafter referred to as "City").

WITNESSETH:

WHEREAS, Subsection 212.055(1), Florida Statutes, provides the County the authority to levy, in addition to other taxes allowed by law, a charter county and regional transportation system sales surtax (hereinafter referred to as "surtax") pursuant to ordinance adopted by a majority of the members of the board of county commissioners and approved by a majority of the electors of the County; and,

WHEREAS, Subsection 212.055(1)(d)(4), Florida Statutes, provides that the proceeds of the surtax levied may be distributed according to an interlocal agreement between the County governing body and the governing bodies of the municipalities; and,

WHEREAS, the County, in anticipation of the levy of the surtax, desires to establish by interlocal agreement the projects to be funded by the surtax and the distribution percentage for providing surtax proceeds to the City.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, and pursuant to Section 163.01, et. seq., Florida Statutes, the Florida Interlocal Cooperation Act of 1969, and Subsection 212.055(1)(d)(4), Florida Statutes, the parties hereto agree as follows:

- 1. <u>Purpose</u>. This Agreement provides for the County's distribution of the surtax proceeds to the City and identifies transportation projects.
- 2. <u>Distribution Percentages</u>. Upon the levy of surtax, <u>43.24%</u> of the proceeds of the 1 percent (1%) sales surtax transmitted to the County by the Department of Revenue each month shall be distributed to the City of <u>Gainesville</u>.
- 3. Term. This agreement shall take effect on the day and year first above written and shall continue until all surtax proceeds are expended for the purposes identified in paragraph 4, below. As required by Subsection 212.055(1)(d)(4), Florida Statutes, County shall review this Agreement no later than five (5) years from the date of execution in order to include within the distribution of surtax proceeds any municipalities that have been created since the execution of this Agreement. The levy of the surtax shall commence on January 1, 2015, and shall continue for a period of eight (8) years from that date and terminate on December 31, 2022, provided a majority of the electors in the County approve the levy of the surtax at a referendum called for such purpose.
- 4. <u>Use of Surtax Proceeds</u>. The surtax proceeds shall be used for the planning, development, construction, operation, and maintenance of roads and bridges; for the planning, development, expansion, operation, and maintenance of bus systems; for the planning, development, construction, operation, and maintenance of on-demand transportation services; and for the payment of principal and interest on bonds issued for the construction of bus systems, roads, or bridges. The City is solely responsible for using its distribution of surtax proceeds in

accordance with this paragraph, county ordinance and State law. In the event the City's use of the surtax proceeds is challenged in a court of law by a party other than the County, the City shall be solely responsible for the defense and/or settlement of the litigation as to its use, and shall defend, indemnify and hold harmless the County for any judgment resulting from City's use of the surtax. The County may, in its sole discretion, participate in any cause of action in which it is also named, or seek to intervene in any cause of action, as necessary for the support of its Ordinance or its use of the surtax proceeds.

- 5. <u>County Project Lists</u>. The County shall use its surtax proceeds as follows:
- (a) Ninety-five percent (95%) of the County's surtax proceeds shall be used in accordance with Exhibit "A" ("Alachua County Road Reconstruction, Resurfacing, Paving and Maintenance Projects."
 - (1) The Board of County Commissioners may delete projects from the list set forth in Exhibit "A" only if the projects deleted are funded by another revenue source or if project costs or other practical constraints make the project unfeasible during the term of the tax.
 - (2) No project may be added to those set forth in Exhibit "A".
 - (3) The priority of the projects set forth in Exhibit "A" shall be at the discretion of County, and modification to any priority of projects shall not require amendment to this Agreement.
 - (4) Funds allocated to the County shall not be used to reduce the number of travel lanes on a county road.

- (5) Funds allocated to the County may be used to construct or maintain paved shoulders which may be marked as bicycle lanes, and pedestrian infrastructure associated with the roadway project.
- (b) Five percent (5%) of the County's surtax proceeds shall be used in accordance with Exhibit "B" ("Alachua County Bicycle and Pedestrian Projects).
 - (1) The Board of County Commissioners may delete projects from the list set forth in Exhibit "B".
 - (2) No project may be added to those set forth in Exhibit "B".
 - (3) The priority of the projects set forth in Exhibit "B" shall be at the discretion of County, and modification to any priority of projects shall not require amendment to this Agreement.
- 6. <u>City Project List</u>. The City shall use surtax proceeds only for those projects identified in Exhibit "C" (City of <u>Gainesville</u> Transportation System Project List). The priority of the projects set forth in Exhibit "C" shall be at the discretion of City, and modification to any priority of projects shall not require amendment to this Agreement.
- 7. Oversight of Funds. City and County both acknowledge that the use of surtax proceeds by all entities shall be subject to a citizen oversight committee, which shall review annually an independent audit of expenditures of each local government's transportation surtax proceeds. City agrees that it will cooperate with the oversight committee, and that it will provide, no less than annually, financial records of its use of the surtax proceeds pursuant to Section 218.39, Florida Statutes, for auditing purposes. City shall timely respond to requests for information or documentation regarding its use of surtax proceeds from either County or the oversight committee.

- 8. <u>No Third Party Beneficiaries.</u> This Agreement is for the exclusive benefit and convenience of the City and the County. Nothing contained herein shall be construed as granting, vesting, creating or conferring any right of action or any other right or benefit upon any third party.
- 9. <u>Counterparts</u>. This agreement may be executed in counterparts and each fully executed counterpart shall be deemed an original instrument.
- 10. <u>Point Of Contact</u>. The day-to-day dealings between the County and the City shall be between the County Manager, for the County and the City Manager, for the City.
- Notices. Except as otherwise provided in this Agreement any notice of default or termination from either party to the other party must be in writing and sent by certified mail, return receipt requested, or by personal delivery with receipt. 12. <u>Default of Agreement</u>. If either party fails to keep and perform each and every covenant it has agreed to keep and perform, the other party, after giving the defaulting party

notice of the default and 30 days to correct the default, and the default remains, may terminate this agreement. Termination may only occur upon a vote of a majority of the membership of the governing body of the party seeking to terminate, which action shall be taken at a public meeting. Reasonable notice of such public meeting must be provided the defaulting party in the same manner as set forth in Section 11, Notices.

- 13. <u>Amendment</u>. The County and City may amend this agreement by written agreement only upon a vote of a majority of the membership of each party's governing body.
- 14. <u>Indemnification</u>. The County and the City, as political subdivisions of the State of Florida as defined in Section 768.28, Florida Statutes, agree to be fully responsible for their respective negligent acts or omissions which in any way relate to or arise out of this agreement. Nothing herein shall be construed as consent by an agency or subdivision of the State of Florida to be sued by third parties in any matter arising out of this agreement or as a waiver of sovereign immunity by any party to which sovereign immunity applies.
- 15. Right to Require Performance. The failure of either party, at any time, to require performance of any provision hereof shall in no way affect the right of said party thereafter to enforce same. Nor shall waiver by either party of any breach of any provision hereof be taken or held to be a waiver of any succeeding breach of such provision or as a waiver of any provision itself.
- 16. <u>Venue</u>. This Agreement shall be governed by the laws of the State of Florida.

 Any and all legal action necessary to enforce this Agreement will be held in the 8th Judicial

 Circuit of the State of Florida and the Agreement will be interpreted according to the laws of the State of Florida.

- 17. <u>Severability</u>. In the event that any provision of this Agreement shall be declared illegal, void or unenforceable by a court of competent jurisdiction, or in an arbitration proceeding, the other provisions shall not be affected but shall remain in full force and effect.
- 18. <u>Filing with the Clerk of Court</u>. A copy of this agreement and all subsequent amendments hereto shall be filed with the Clerk of Circuit Court of Alachua County, Florida, upon its execution by all parties hereto.
- 19. Entire Agreement. This Agreement is the entire agreement between the parties and all understandings and agreements are incorporated in this Agreement. This Agreement supersedes any prior agreements between the parties relating to the local government infrastructure surtax.
- 20. <u>Non Waiver</u>. The failure of either party to exercise any right contained in this agreement shall not be considered waiver of such right.
- 21. <u>Attachments</u>. All exhibits attached to this agreement are incorporated into and made a part of this agreement.
- 22. <u>Recording of Agreement</u>. The County, upon execution of this Agreement, shall record the agreement in the public records of Alachua County.
