2 3 4 5 6 7 8 9 10 11	An ordinance amending the Future Land Use Map of the City of Gainesville Comprehensive Plan by changing the land use category of approximately 40.2 acres of property generally located northwest of Morningside Nature Center in the 2800 block of NE 11 th Place, as more specifically described in this ordinance, from Alachua County Low Density Residential to City of Gainesville Conservation (CON); providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an effective date.			
12	WHEREAS, notice was given as required by law that the Future Land Use Map of the			
13	City of Gainesville Comprehensive Plan be amended by changing the land use category of the			
14	property that is the subject of this ordinance from Alachua County Low Density Residential to			
15	City of Gainesville Conservation (CON); and			
16	WHEREAS, on February 27, 2014, a public hearing was held by the City Plan Board,			
17	which acts as the local planning agency pursuant to Section 163.3174, Florida Statutes, and			
18	makes recommendations to the City Commission of the City of Gainesville; and			
19	WHEREAS, an advertisement no less than two columns wide by ten (10) inches long			
20	was placed in a newspaper of general circulation and provided the public with at least seven (7)			
21	days' advance notice of this ordinance's first public hearing to be held by the City Commission			
22	in the City Hall Auditorium, located on the first floor of City Hall in the City of Gainesville; and			
23	WHEREAS, after the first public hearing, the City of Gainesville transmitted copies of			
24	this proposed amendment to the reviewing agencies and any other local government unit or state			
25	agency that requested same; and			
26	WHEREAS, a second advertisement no less than two columns wide by ten (10) inches			
27	long was placed in the aforesaid newspaper and provided the public with at least five (5) days'			
28	advance notice of this ordinance's second public hearing to be held by the City Commission; and			
29	WHEREAS, public hearings were held pursuant to the notices described above at which			

1 hearings the parties in interest and all others had an opportunity to be and were, in fact, heard;2 and

WHEREAS, prior to adoption of this ordinance the City Commission has considered any
written comments received concerning this amendment.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE

6 CITY OF GAINESVILLE, FLORIDA:

Section 1. The Future Land Use Map of the City of Gainesville Comprehensive Plan is
amended by changing the land use category of the following property from Alachua County Low
Density Residential to City of Gainesville Conservation (CON):

See legal description attached hereto as Exhibit "A" and made a part
hereof as if set forth in full. The location of the property is shown on
Exhibit "B" for visual reference. In the event of conflict or inconsistency,
Exhibit "A" shall prevail over Exhibit "B".

15 Section 2. Within ten (10) working days of the transmittal (first) hearing, the City 16 Manager or designee is authorized and directed to transmit this amendment and appropriate 17 supporting data and analyses to the reviewing agencies and to any other local government or 18 governmental agency that has filed a written request for same with the City. Within ten (10) 19 working days of the adoption (second) hearing, the City Manager or designee is authorized and 20 directed to transmit this amendment to the state land planning agency and any other agency or 21 local government that provided comments to the City regarding the amendment.

Section 3. The City Manager or designee is authorized and directed to make the necessary changes to maps and other data in the City of Gainesville Comprehensive Plan in order to comply with this ordinance.

25 **Section 4.** If any word, phrase, clause, paragraph, section or provision of this ordinance 26 or the application hereof to any person or circumstance is held invalid or unconstitutional, such

finding shall not affect the other provisions or applications of this ordinance that can be given
 effect without the invalid or unconstitutional provision or application, and to this end the
 provisions of this ordinance are declared severable.

4 Section 5. All ordinances or parts of ordinances in conflict herewith are to the extent of
5 such conflict hereby repealed.

Section 6. This ordinance shall become effective immediately upon adoption; however, the 6 effective date of this amendment to the City of Gainesville Comprehensive Plan, if the amendment is 7 not timely challenged, shall be 31 days after the state land planning agency notifies the City that the 8 amendment package is complete in accordance with Section 163.3184, Florida Statutes. If timely 9 challenged, this amendment shall become effective on the date the state land planning agency or the 10 Administration Commission enters a final order determining this adopted amendment to be in 11 compliance with Chapter 163, Florida Statutes. No development orders, development permits, or 12 land uses dependent on this amendment may be issued or commenced before this amendment has 13 become effective. 14
