## **CURRENT ACTION ITEMS**

#### **<u>130669.</u>** Low-income Energy Efficiency (LEEP) Program (B)

Staff gave a presentation on GRU's LEEP program. The Committee raised questions about whether the program could be expanded to include rental houses and the discussion continued. The Committee members agreed to keep this item in committee, with direction to staff to bring possible program options that include landlords/rentals to a future meeting.

Additional discussion centered on possible funding sources for the Community Weatherization Coalition (CWC), with the goal of expanding the reach of their work. Staff also mentioned that they could coordinate with the CWC on possible grant funding opportunities through the American Public Power Association's (APPA) Demonistration of Energy & Efficiency Developments (DEED) program.

**RECOMMENDATION** The Regional Utilities Committee receive a brief presentation from staff on the Low-income Energy Efficiency Program (LEEP) and a summary of results for FY14.

A motion was made that the committee take a recommendation to the full Commission for \$3,000 from this year's LEEP budget to be donated to the Community Weatherization Coalition (CWC), and that a \$25,000.00 increment be requested in the FY16 Conservation Services budget for assistance to the CWC. If approved by the City Commission and prior to distribution of funds, staff would develop appropriate monitoring criteria for the use of these funds.

The motion passed unanimously.

Staff made a presentation on Green Energy Payment options. Kik Koppitch discussed several existing programs in place at municipal utilities around the country, as well as a discussion of GRU's practice of selling Renewable Energy Credits (RECs.) Chair Chase asked staff to report back the revenue received in 2014 from the sale of RECs.

Chair Chase stated that he wanted to keep this item in committee and asked staff to report back on how the cost to administer GRUGreen compared to the amount of money received in donations.

**RECOMMENDATION** Hear a presentation from staff regarding options for green energy pricing program, and considerations for the potential development of such programs.
