An ordinance amending the Zoning Map Atlas of the City of Gainesville, Florida, by rezoning approximately 97.8 acres of property that is generally located north of Morningside Nature Center, as more specifically described in this ordinance, from Alachua County Agriculture (A) to City of Gainesville Conservation District (CON); providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an effective date.

WHEREAS, notice was given as required by law that the Zoning Map Atlas of the City of Gainesville, Florida, be amended by rezoning certain property from Alachua County Agriculture (A) to City of Gainesville Conservation District (CON); and

WHEREAS, on January 22, 2015, a public hearing was held by the City Plan Board, which acts as the local planning agency pursuant to Section 163.3174, Florida Statutes, where it voted to recommend that the City Commission adopt this ordinance; and

WHEREAS, an advertisement no less than two columns wide by ten (10) inches long was placed in a newspaper of general circulation and provided the public with at least seven (7) days' advance notice of this ordinance's first public hearing to be held by the City Commission in the City Hall Auditorium, located on the first floor of City Hall in the City of Gainesville; and

WHEREAS, a second advertisement no less than two columns wide by ten (10) inches long was placed in the aforesaid newspaper and provided the public with at least five (5) days' advance notice of this ordinance's second public hearing to be held by the City Commission; and

WHEREAS, the public hearings were held pursuant to the notice described above at which hearings the parties in interest and all others had an opportunity to be and were, in fact, heard; and

WHEREAS, the City Commission finds that the rezoning of the property described herein will be consistent with the City of Gainesville Comprehensive Plan when City of

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE 2 3 CITY OF GAINESVILLE, FLORIDA: Section 1. The Zoning Map Atlas of the City of Gainesville is amended by rezoning the 4 following property from Alachua County Agriculture (A) to City of Gainesville Conservation 5 District (CON): 6 See legal description attached as Exhibit "A" and made a part hereof as if set 7 forth in full. The location of the property is shown on Exhibit "B" for visual 8 reference. In the event of conflict or inconsistency, Exhibit "A" shall prevail 9 over Exhibit "B". 10 11 **Section 2.** The City Manager or designee is authorized and directed to make the 12 necessary changes to the Zoning Map Atlas to comply with this ordinance. 13 14 Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance 15 or the application hereof to any person or circumstance is held invalid or unconstitutional, such finding shall not affect the other provisions or applications of this ordinance that can be given 16 effect without the invalid or unconstitutional provision or application, and to this end the 17 provisions of this ordinance are declared severable. 18 **Section 4.** All ordinances or parts of ordinances in conflict herewith are to the extent of 19 20 such conflict hereby repealed. Section 5. This ordinance shall become effective immediately upon adoption; however, 21 the rezoning shall not become effective until the amendment to the City of Gainesville 22 Comprehensive Plan adopted by Ordinance No. 140695 becomes effective as provided therein. 23 PASSED AND ADOPTED this _____ day of _______, 2015. 24 25 26
