# The Basic Framework of Our Municipal Government

- Brief -- 14 pages long (+ legal description of City boundaries)
- Created by Special Act of the Florida Legislature
- Organized into 6 Articles





# Article I. Establishment, Corporate Limits, and Powers

- Created by Chapter 12760, Laws of Florida, 1927
- General Powers
  - "... exercise any power for municipal purposes, except as otherwise provided by law."

#### Special Powers

- Acquire & manage property
- Acquire & manage utilities
- Finance utilities
- Enter interlocal agreements
- Exercise the power of eminent domain
- Exercise police powers

- Provide fire protection services
- Issue bonds
- Levy taxes
- Compel the abatement of nuisances
- Own & operate public transportation
- Others





#### Article II. City Commission

- Legislative power vested in the Commission
- Number of Commissioners
- Mayor, At-large, and District members
- Eligibility & term limits
- Filling vacancies
- Commission as judge of qualifications of members
- Prohibition on interference with Charter Officers





#### Article III. Administration

- <u>Charter Officers</u> vested with authority to administer the assigned duties of their offices including the employment and removal of subordinate employees.
  - City Manager
  - City Attorney
  - General Manager for Utilities
  - Equal Opportunity Director
  - Clerk of the Commission
  - City Internal Auditor





#### Article IV. Boards and Committees

- Advisory Boards and Committees created by the Commission as it deems necessary
- City Plan Board shall be created by the Commission
  - Prepare, make recommendations pertaining, and monitor effectiveness of Comp Plan
  - Review Land Development regulations and codes and make recommendations as to consistency with Comp Plan
- Building and Land Development Regulatory Boards may be created by Commission
  - Hear and decide appeals of administrative decisions regarding enforcement of building or land development regulations
  - Hear and decide Special Exceptions
  - Grant Variances





### Article V. Special Provisions

- Charter Amendments (requires 4/5 majority of Commission)
- Issuance of Ad Valorem Bonds
- Retirement and Pension Plan for City Employees (requires 4/5 majority of Commission)
- Disposal of Utilities (requires majority vote of Electors)
- Fresh Pursuit and Arrest by Municipal Officers
- Prohibition of paved surfaces for trails or transportation on Cityowned Conservation land within Hogtown Creek Watershed
- Equal Opportunity; Duties of Charter Officers
- Registry of Protected Public Places (requires 5/7 majority of Commission)





#### Article VI. Transition Schedule

• Concerns original implementation of Charter





#### Amending the Charter

- Special Act of the Legislature
- Ballot Referendum
  - Petition signed by > 10% of City electors, or
  - 4/5 majority of Commission
  - City Commission places referendum on ballot by passage of ordinance
  - Single-subject requirement per ballot item
  - Ballot language must not be > 75 words
  - Special advertising requirements (4 consecutive weeks)
