17	WHEREAS, the Alachua County Property Appraiser certified the 2015 taxable values to
18	the City Commission of the City of Gainesville, Florida on June 26, 2015.
19	WHEREAS, Section 200.065, Florida Statutes, requires the City Commission to advise
20	the Property Appraiser of its rolled-back millage rate, its proposed millage rate, and of the time,
21	date, and place at which a public hearing will be held to consider the proposed millage rate and
22	the proposed tentative budget.
23	WHEREAS, the gross taxable value for operating purposes not exempt from taxation
24	within Alachua County has been certified by the County Property Appraiser to the City of
25	Gainesville as \$5,788,526,801.
26	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE
27	CITY OF GAINESVILLE, FLORIDA:
28	Section 1. The proposed millage rate necessary to fund the proposed tentative general
29	purpose municipal budget for the City of Gainesville's 2015-2016 fiscal year is mills.
30	Section 2. The FY 2015-2016 proposed operating millage rate is mills, which is
31	than the rolled-back rate of 4.4550 mills by%.

1	Section 3. A public hearing will be held to consider the proposed millage rate and the
2	proposed tentative budget for general municipal purposes on Thursday, September 10, 2015, at
3	six o'clock p.m., or as soon thereafter as the matter may be heard, in the City Hall Auditorium on
4	the first floor of City Hall, 200 East University Avenue, City of Gainesville, Florida.
5	Section 4. The City Manager is hereby authorized and directed to provide a copy of this
6	resolution to the Alachua County Property Appraiser for use in preparing the Notice of Proposed
7	Property Taxes, as required by Section 200.069, Florida Statutes, and to execute, as the
8	Administering Official, any Department of Revenue forms necessary to complete this
9	certification.
10	Section 4. This resolution shall take effect immediately upon its adoption.
