Item #130812 - GRU Electric Wholesale Sales Strategy: The Committee tasked the General Manager with developing guidelines for when to seek City Commission approval for negotiating wholesale power contracts. No timeline was mentioned.

Item #130755 - Electric Utility Market Restructuring: This referral is the result of a presentation to the City Commission by Darrin Cook of Infinite Energy. The Committee voted to have the GM speak with Mr. Cook about his idea, monitor any energy related regulatory changes and revisit this item in committee in one year (August 2016.)
