# Presentations

1. <u>I-75 Relief Task Force Update</u> **Amount:** NA **Recommended Action:** Hear the presentation.

Transportation Planning Manager Jeff Hays presented the above item.

Commissioner Byerly presented comments.

Commissioner Cornell requested the following amendments to the letter:

The first area relates to the accessibility of the Task Force meetings to the general public. While it is understandable for the Task Force to hold meetings throughout the study area <u>because these</u> <u>meetings appear to be cumulative in nature which building on the previous</u>, it creates a hardship on residents who must travel significant distances to attend. We would request that all Task Force meetings be videotaped and made available for streaming in order to provide for convenient public access and a complete and accurate public record of the proceedings.

The third area relates to the Task Force "private landowner" position on the Task Force. Apparently, Mr. Todd Powell has resigned his position on the Task Force. The County would recommend that Mr. Powell be replaced with a resident landowner who owns property in the rural area of the study area but does not have a specific business interest in the outcome of the study. The County Commission could provide some recommendations on residents of Alachua County who have been involved in the process from the beginning and meet that description.

Also in the letter acknowledge the response from Mr. Wood in the letter and add language stating that the County has attached and are reviewing the previous recommendations in the final report have been attached for reference.

Commissioner Byerly stated that a request for live streaming be worked into the second sentence of the second paragraph.

Chair Hutchinson, and Commissioner Byerly presented comments.

Chair Hutchinson requested that Communications Coordinator Mark Sexton make the March 29, 2016 meeting really apparent in the County's social media and so forth.

- 3. Meet with federal, state, and local land conservation agencies and organizations to seek matching funding options for conservation land purchases.
- 4. Schedule a Joint Meeting Workshop with the City of Gainesville, University of Florida, and Santa Fe College regarding the Waldo Road Job Center.

County Manager Niblock stated that Weyerhaeuser has provided the appraisals of the land for the Fairgrounds land swap. Staff is currently reviewing them and will continue to move forward in the process.
