Video System

Security 101 proposes to modify existing CCTV and intercom systems for City of Gainesville RTS Maintenance Facility as described herein.

Provide and install TEN new cameras and two additional NVRs, re-position FOUR existing cameras (three in Maint Bldg & one in Admin Bldg), relocate two existing cameras and provide and install a new additional intercom master station per details as follows. This quantity of TEN new cameras includes eight which contain four lenses in each camera housing thereby providing a total of 32 camera images plus two single image fixed cameras; which in total will add another 34 camera images to the existing CCTV network.

Addition of new cameras will require increase in CCTV recording hardware, software and licenses. An additional TWO 32 channel NVRs will be added in same location along with other SIX existing units. Rack space, 120vac power, UPS, CISCO switch(es)/network infrastructure, etc. as required is not included by Security 101 and is the responsibility of others.

Security 101 will provide and install fiber media converters with fiber jumpers which will bring video signals in from FOUR new parking lot cameras to land on GRU supplied Cisco switch/SFP port(s). The FOUR new 2nd story cameras, each will require an available POE port on City's network. Switches, SFP modules, IP addresses, 120vac and other related network infrastructure is not provided by Security 101 and is the responsibility of others.

Security 101 will remove two existing 8MP Arecont Camera installed in employee parking lot and replace with two new 20MP camera in their place. The two existing 8MP Arecont cameras will be re-installed in new locations on the Admin building; one at the visitor entrance and other at the employee entrance.

Security 101 will provide and install four new 20MP Arecont cameras, NEMA enclosures and all related infrastructure on four poles in corners of employee parking lot. This work will utilize existing pre-installed buried conduit and pre-cast poles. All Florida Electric Company is working with Security 101 (as our sub-contractor) to provide and install required 120vac and associated components at each pole location in the parking lot - these sub-contractor fees are included in this contract pricing. Also please note that the use of a suitable man-lift (i.e. scissors or boom lift) will be required during this project and such rental fees are included.

Security 101 will extend pendant mount pole at FOUR locations on existing cameras to increase distance further down from ceiling for better views around obstructions (in Maint Bldg) and into Kitchen (in Admin Bldg).

Security 101 will provide TWO additional Max-Pro viewing client licenses to be installed on PCs located in Central Command Center and in Driver's Dispatch areas which will allow camera monitoring and control at such locations.

Security 101 will provide and install an additional intercom master station in command center.

Work will be performed during normal work hours (i.e. 8am-5pm M-F). Support and assistance from City of Gainesville RTS and/or GRU personnel will be required during project timeframe.

To the extent not otherwise warranted pursuant to an applicable manufacturer's warranty, Security 101 warrants all Equipment and installation labor rendered as part of the Work against defects in materials and labor for a period of twelve (12) months (the 'Warranty Period') from the date of substantial completion of the installation; provided, however, no warranty is made as to, and there is specifically excluded from the warranty, any and all expendable supplies, equipment and parts, or any portions of the Work which have been misused, abused, not used in the manner intended, neglected, or damaged by an act of God or altered, modified, or manipulated in any manner by Customer or a third party. Any defect in the installation during the Warranty Period will be repaired or replaced at the option of Security 101 Any shipping charges in connection with a repair or replacement shall be the responsibility of Customer. The repair or replacement shall constitute Customer's sole remedy against Security 101.
- 2. Additional training, programming or related consulting services provided by Security 101 at Customer's request shall be provided at an above contract cost.

10. Drawings:

- (i) To the extent required by the design and specifications of the Work, Security 101 shall provide reasonable descriptions of the functional operation of the system(s) being provided by the Work.
- (ii) Security 101 may provide, at Customer's request and at an above contract cost, detail drawings utilizing industry standard electronic floor plans.
- 11. Ownership. Prior to completion of the Work, any drawings, specifications and equipment lists developed in connection with the design for the Work shall remain the property of Security 101 whether the Work for which they were made is executed or not.
