

**PROJECT/ACTIVITY REPORT****GRUCOM****Major Operational/Construction Issues:**

Currently reaching normal installation lead times for new services after delays due to resources dedicated to SBAC project; some customers requesting quotes for expedited service installation.

**Capital/Maintenance Project Status:**

- 17584 GRUCOM: REPLACE FIBER - ACPW TO ALACHUA SUBSTATION (Replacing old cable and up-sizing to provide more capacity to points north of Deerhaven)
- 17273 GRUCOM: FIBER DAMAGE 1/5/15 AT 500 SW DEPOT AVE
- 17596 GRUCOM: ARCHER RD CABLE REPLACEMENT (Old cable replacement and upsize)
- 17615 GRUCOM: NEW 144 CT FIBER BTWN PARKER RD SUB AND FT CLARK CABINET (Old cable replacement and upsize)

**Items for Board Approval:**

None at this time.

**Good News:**

- SBAC Project - GRUCom has completed a private, fiber-optic ringed network for the exclusive use of SBAC. The network enables 10 gigabits per second (Gbps) of available bandwidth to *each* public school in the county, plus an option to increase the installed bandwidth capability up to 20 Gbps.
- Installing fiber service (100Mb) to ACLD Newberry Library Branch.
- Installing fiber service to the new Alachua County Tax Collector's office in Butler Plaza.
- Installing fiber service to the new Regional Transit System (RTS) transfer station in Butler Plaza.
- Installing fiber service to the new City of Gainesville Parks, Recreation and Cultural Affairs facility at Depot Park.
- Installing new Internet service to the Eighth Judicial Circuit court offices in the Alachua County Civil Courthouse.
- Installing new Internet services to the Jordan Glen School & Summer Camp campus in Archer, FL.
- Installing GatorNet 100Mb service to the 140 residential housing units in the Casablanca East condominium community (bulk agreement with the HOA).
- Data service contract with the Malcom Randall VA Medical Center was renewed for next year with 5 x one year renewal options (~\$15k/month in revenues).
- Installing fiber service to the new UF Health Shands HomeCare facility located at 1610 NW 23 Ave (the old Alachua County Social Security office north of Lucky's Market).
- Installing fiber service to the new UF Health Neurosurgery offices to be located in the Florida Farm Bureau Insurance Building.

**Anticipated Major Items (30/60/90 Days):**

- Trunk Radio System – GRUCom is working with the Radio Management Board (Public Service Radio user group) to define requirements and execute a new inter-local agreement (ILA) to upgrade service and expand coverage in Alachua County.
