Staff recommended to sunset initiatives that were accomplished; have become part of everyday operations; or are outside of the sole capacity of the City. Commissioners completed scorecards based upon the staff presentation in order to develop a starting point for a prioritization discussion. Following input from several citizens, the Commission collaboratively sunset eight initiatives, added eight new initiatives and organized all initiatives into three categories: highest priority, higher priority, and high priority. The established prioritization will assist staff in resource allocation when there is more than one initiative competing for the same pool of resources.

Using a ballot process, the Commission selected initiatives to sponsor. Each Commission member was given the opportunity to select and rank initiatives they would like to sponsor. Among the ranked selections, each participating member has been assigned three to four initiatives, including their number one choice as its sole sponsor. 

