#### **FEE ESTIMATE**

Our fees are based on the timely delivery of services provided, the experience of personnel assigned to the engagement, and our commitment to meeting your deadlines. Please note that this proposal is not a joint venture. As requested in the City of Gainesville, Florida's (the City) Request for Proposal (RFP) NO. CAUD-170010-DH, the first year fee will be adjusted according to the previous year's Consumer Price Index (CPI) for the Southern region all urban consumers, all items with a five (5) percent limit on any increase. No decrease will be implemented if the CPI happens to fall in any particular year. However, future adjustments will be measured from the base year's (first year contract) CPI index to the future CPI index, minus the increases already provided, again not allowing a decrease in any year.

CliftonLarsonAllen (CLA) understands the importance of providing our clients with value-added solutions. We propose to provide routine, proactive quarterly meetings—as part of our fee—that will allow us to review and discuss with you the impact of new accounting issues, as well as any other business issues you are facing and how they should be handled.
