CFO Justin Locke presented the item to the Board with an explanation of why GRU is requesting the water rate change for UF. Staff addressed numerous questions from the Board about the water agreement with UF and the formula used to calculate their rates. Discussion ensued about the General Fund Transfer and how it is distributed across the business community and the Board agreed that they would discuss the topic further in the future.

Member Denslow made a motion to agree with staff's recommendation to the City Commission, and Member Walpole seconded. The motion passed 5-0 with Members Alford and Selvester absent.

**RECOMMENDATION** The City Commission direct the City Attorney to draft, and the Clerk of the Commission to advertise an ordinance to adopt the recommended rates, fees and charges for Water for the University of Florida.

City Attorney Shalley introduced the item and discussed some of the materials she provided to educate the Board. The Board asked if there was any approval authority that the Commission could cede to the Board. After much discussion, Ms. Shalley stated that any specific thing that the Board wanted to ask to have ceded to them would have to be researched and thought through to determine the impacts and whether it would require a charter change. It would then have to go before the City Commission so they could make a policy decision.

The Board asked Ms. Shalley to prepare information regarding what the impact would be if the Commission ceded the authority to fix utility rates to the Board for discussion at the January 12, 2017 Joint Commission/ UAB meeting. Ms. Shalley agreed.

**RECOMMENDATION** 

The City Attorney has provided historical records of meetings where GRU governance was discussed and will be at the meeting to address any questions Board members may have.

#### MEMBER COMMENT

Member Orlando informed the Board that at the December 1, 2016 City Commission meeting, a citizen requested that the Board's draft rules be pulled from the consent agenda for discussion. She stated that the citizen had sent an email to the Commission expressing concerns with the Board's rules and the email was read into the record by Commissioner Charles Goston. Ms. Orlando said she told the Commission that she was not comfortable with the rules and requested that they be sent back to the Board for review and possible changes. The Commission agreed to

#### do that.

*Ms.* Orlando stated that she also had concerns with the rules, in particular citizen comment and agenda setting, and some others as well.
