
Petition Overview

- Amends Land Development Code (LDC) for consistency w/expanded 2016 state law
- Clarifies that Medical Marijuana Dispensaries may dispense cannabis to medical patients for medical purposes per Sec. 381.986, F.S., as may be amended from time to time
- Should state law change to allow different types of medical marijuana or different types of medical patients, our LDC would automatically allow such change
- LDC amendment will strictly limit dispensing to medical marijuana
- Any future state law change allowing dispensing of recreational marijuana would need to be considered by City Commission before such use could be allowed, unless City's authority preempted by FL Legislature

✓ Minimum distances to: places of religious assembly 300 ft.); residential zoning districts (500 ft.); and schools (750 ft.)

 ✓ Prohibitions on what can be dispensed or sold (e.g., no alcohol)

### **Delete Definition**

#### Low-THC cannabis

means a plant of the genus Cannabis, the dried flowers of which contain 0.8 percent or less of tetrahydrocannabinol and more than 10 percent of cannabidiol weight for weight; the seeds thereof; the resin extracted from any part of such plant; or any compound, manufacture, salt, derivative, mixture, or preparation of such plant or its seeds or resin that is dispensed only from a Medical marijuana dispensary (as defined in this code.)



## **Revise Definition**


#### Medical marijuana dispensary

means a facility that dispenses cannabis to medical patients for medical purposes pursuant to and in accordance with Section 381.986, Florida Statutes, as may be amended from time to time. dispensary organization approved by the Florida Department of Health pursuant to and in accordance with the regulations of the "Compassionate" Medical Cannabis Act of 2014" (codified in Section 381.986, Florida Statutes) to cultivate, process, and dispense low-THC cannabis to Florida residents who have been added to the state compassionate use registry by a physician licensed under Chapter 458 or Chapter 459, Florida Statutes, because the patient is suffering from cancer or a physical medical condition that chronically produces symptoms of seizures or severe and persistent muscle spasms with no other satisfactory alternative treatment options.

City Plan Board Recommendation to City Commission Approve Petition PB-16-185 TCH

(Plan Board voted 4-2) with the following revisions:

Allow all cannabis products legally established now or in the future by the State of Florida

Continue to allow Medical marijuana dispensary as a permitted use in all of the zoning districts (OR, OF, BUS, MU-1, MU-2, UMU-1, UMU-2, CCD; MD and CP) in which it is currently a permitted use

Limit the proposed Specially Regulated Use Requirements (Article VI) for Medical marijuana dispensary to a 1,320-ft. minimum distance between Medical marijuana dispensaries, and to a 750-ft. minimum distance to schools (accredited public or private school offering any grades from kindergarten through 12<sup>th</sup> grade)
