3. Preference in bidding& fiscal impact

 - Monetary cap of \$25,000 in bids
 - Business in City limits
- Small Business Preference
 - Evaluation based solicitations >\$50,000
 - 5% of points
 - No monetary cap
 - Small business definitions for GRU and City
